I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act- 2007, to the effect that AKUL SAHIS, having consumer ID- 242169453 and meter number- I026255 of Vill- BHELAIDIH, P.S- Barabazar , Dist- Purulia was enjoying electricity unauthorizedly by illegal hooking from nearest LTOH line with the help of two core flexible wire and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 10.11.2017, I Sri Amit Sing, S.A.E. & S.M., BARABAIZAR CCC, WBSEDC along with

- (1) CHANDI CHARAN KARMAKAR, ACM, BARABAIZAR CCC, WBSEDC
- (2) MD QASIM ANSARI, O.E., BARABAIZAR CCC, WBSEDC

At About 12:30 P.M., entered into the premises of AKUL SAHIS of Vill- BHELAIDIH, P.S- Barabazar , Dist- Purulia and inspected his premises at Vill.- BHILAI DIH, P.S Barabazar, DIST- Purulia.

During inspection, it was found that AKUL SAHIS of Vill- BHELAIDIH, P.S- Barabazar , Dis- Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of two core flexible wire in his premises at BHELAIDIH having connected load 0.235 KVA. He is a consumer of WBSEDC having consumer ID- 242169453 and meter number- I026255 and his connection was disconnected on 13.07.2013 due to outstanding amount and his connection was deemed after six months of disconnection.

From the above arrangement he was using the following equipment:

01. Two core flexible cable (10 mt. App.) with switch board and hooking device.
02. 02 No. Bulb (100 Watt each)

Out of which I seized the following articles:

1. Two core flexible cable (10 mt. App.) with switch board and hooking device.
2. 02 No. Bulb (100 Watt each)
