Sir,

With due respect and humble submission I, ASI Swapan Nandi s/o Lt. N.K. Nandi of Bidhan Nagar, Durgapur-6, PS- NTPS, Dist- Burdwan (West) and presently posted at Hura PS beg to state that on 18.11.17 at 13.05 hrs. some villagers of Baragram village came at the PS and reported that there is a Govt. Tubewell and from the wastage water from the said Tubewell the condition of the attached road is getting damaged and for this reason the villagers wanted to build a sockpit near the tubewell on vested land to save the village road. But one Ayub Ansary s/o Lt. Akkel Ansary of Vill- Baragram, PS- Hura, Dist- Purulia created obstacle against constructing of the sockpit on the vested land. This matter noted in Hura PS GDE No- 718 Dtd- 18.11.17 by SI Biswajit Sarkar of Hura PS. As per endorsement of O/C Hura PS, SI Biswajit Sarkar along with force went to Baragram village for field verification where said Ayub Ansary and villagers stated that they will arrange for joint field measurement by the reputed Amin on 22.11.17 at morning. But today on 21.11.17 at 18.05 hrs. when I was engaged as a Table duty officer at Hura PS that time one Abdul Alim Ansary s/o Abarat Ansary of Vill- Kajuli, PS- Hura, Dist- Purulia and Ayub Ansary of Baragram village accompanying with 25-30 persons under the leadership of Abdul Alim Ansary by creating an unlawful assembly rushed to the table of the duty officer and were throwing slang language against me and on duty police personnel with a undue demand that "কেনো পুলিশ বড়গামে তদন্ত করতে যাবে?" and obstructed to the police personnel in the discharge of our public duty and also used criminal force by pushing me and on duty sentry constable. As a result we fallen on the ground and in this way they committed disturbance to execute public duty. In this situation when I, accompanying with other officers & force chased them that time some of them stumbled on the ground during run though all managed to escape from PS compound.

Therefore I, pray before your honour that a specific case may kindly be initiated against i) Abdul Alim Ansary s/o Abarat Ansary of Vill- Kajuli, PS- Hura, Dist- Purulia, ii) Ayub Ansary s/o Lt. Akkel Ansary of Vill- Baragram, PS- Hura, Dist- Purulia and 25-30 others under the proper section of law and obliged.
