Sir,

In producing here with arrested accused namely Netai Sardar (34 Yrs) s/o Khandú Sardar of Vill- Debipur, PO- Rakhera, P.S-Hura Dist-Purulia to start a case U/S - 46 A (c) of the Bengal Excise Act' 1909 along with seized Country Spirit bottles DILSE, DIL KHUS & CAPTAIN (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 26.11.2017 at 17.25 hrs received a credible source information vide Hura P.S. GDE No. 1052 Date.-26/11/2017 and to work out the same. I ASI Swapan Nandi along with force held raid (18.15 hours to 19.25 hours.) in the house of Netai Sardar (34 Yrs) s/o Khandu Sardar of Vill- Debipur, PO- Rakhera, P.S-Hura Dist-Purulia at Debipur Village under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country sprit which was kept in his house at Debipur village, PS-Hura Dist. Purulia, On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Then, I seized all the sealed Country Spirit bottles Total 16 (Sixteen) Plastic bottles country sprit (DILKHUS) have been seized; measuring 600 ML each bottle and value Rs. 35/- each Total value Rs- 560/- and Total 05 (Five) plastic bottles country sprit (DILSE) have been seized; measuring 600 ML each bottles and value Rs. 35/- each Total value Rs-210/-, Total 02 (Two) plastic bottles country sprit (CAPTAIN) have been seized; measuring 600 ML each bottles and value Rs. 75/- each Total value Rs- 150/-, and Total Amount- Rs.920/-(details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample three bottles. This is to note here that on seeing police party all public/customers fled away. Accordingly, I arrested him after preparing proper arrest memo, maintained all formalities regarding arrest informed his family member regarding the ground of arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him.

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused person namely Netai Sardar (34 Yrs) s/o Khandu Sardar of Vill- Debipur, PO- Rakhera, P.S-Hura Dist-Purulia and arrange for its investigation.
