I do here by lodged a written complaint against the above noted accused person to the effect that on today (03/11/17) at 14:15 hrs received a telephonic information from my source that 01(one) person is selling syrup beside Jhalda Sarbajonin Durgamandir and huge quantities of drugs with him. After received such type of information I informed I/C Jhalda PS for onward transmutation and as per direction of him myself along with force left from PS and rushed to Jhalda Sarbajonin Durgamandir and keep our vehicle on Jhalda Station road behind Jhalda Sarbajonin Durgamandir. We wait for few times and at 15:05 hrs we found one person was selling syrup. We intercepted him at in front of Sarbajonin Durgamandir Ihalda and on being asked he disclosed his identity as noted above. Manufactured by Elder Pharmaceuticals LTD, batch No-SD17020 Mfg date-May-2017 Expiry date Apr -2019. On demand he failed to produce any valid documents/license in respect of keeping the said drugs and also stated that he use to sell the syrup as demanded by the customers. So I seized the same under proper seizure list duly signed by the witnesses as well as the apprehended person and also prepare label and sell duly singed by the accused person and witnesses on the spot. I arrested the accused person for violating the sec. 27 of drugs & cosmetics Act 1940.

I therefore pray before you to start a case against the above noted arrested accused person under sec. 27 of drugs & cosmetics Act 1940 and arranged for its investigation.
