Sir,

In producing here with one arrested accused person namely Jagabandhu Mahato (48 Yrs) S/o-Lt. Laxmi Narayan Mahato of Vill-Kansra, PS-Jhalda, Dist-Purulia and brought under seizure of the following articles, 32(Thirty Two) sealed bottles of ELTUREX-T syrup(CODIEN PHOSPHATE & TRIPOLIDINE HYDROCHLORIDE) 100 ml in each bottle, manufactured by Elder Pharmaceuticals LTD, batch No-SD17020 Mfg date-May-2017 Expiry date April-2019 in one plastic bag from the possession of the accused person mentioned above. I do here by lodged a written complaint to the effect that on 13.11.17 at 22:15 Hrs I received a telephonic information from my source that Jagabandhu Mahato of Kansra and Sanjoy Keshri of resides near Sarbojanin Durga Mandir under Ward No-V of Jhalda Municipality, both of PS-Jhalda, Dist-Purulia suspiciously standing at Ananda Bazar near Hattola with huge numbers of cough syrup for selling to others. After having received this information I immediately informed to I/C Jhalda PS and diarized the matter at 22:15 Hrs Vide GDE No-496 Dtd-13.11.17 and as per direction of I/C Jhalda PS, I SI Jayanta Majhi along with ASI Mrinmoy Chowdhury, Constable-380, Ajay Kr Roy and HG-1634, Gopal Majhi, all of Jhalda PS left PS at 22:35 Hrs to work out the information vide CC No-3468/17 Dtd-13.11.17 and Vide GDE No-497. We moved from PS with Govt. Vehicle and reached at Ananda Bazar near Hattola at 22:45 Hrs. and suddenly seeing the police party one accused person fled away and the other one has been caught red handed due to hot and little chase. On interrogation he disclosed his name and address as mentioned above and he also disclosed that the other one was Sanjoy Keshri, resides near Sarbojanin Durga Mandir under Ward No-V of Jhalda Municipality. He also disclosed that they are both the Cough Syrup business partner and since long they have been continuing this business and today they have gathered for the purpose of selling drugs to the local boys customers. On being searched one black colour plastic hand bag containing 32 (Thirty Two) sealed bottles of ELTUREX-T Syrup(CODIEN PHOSPHATE & TRIPOLIDINE HYDROCHLORIDE) 100 ml in each bottle Cough Syrup (illegal drugs) found in his possession. On demand he failed to produce any valid documents/ license in respect of keeping the said drugs. So I seized the same under proper seizure list duly signed by the police witnesses as there was no other local witnesses available there right that moment and as well as the apprehended person and also prepared label with seal of one bottle of Cough Syrup as sample taking among seized bottles. I arrested the said accused person for violating the Sec-27 of Drugs & Cosmetics Act-1940 and informed him the ground of arrest. The house of Sanjoy Keshri could not be traced during further raid due to want of identifier.

I therefore pray before you to start a case against both the accused persons namely 1. Jagabandhu Mahato (48 Yrs) S/o-Lt. Laxmi Narayan Mahato of Vill-Kansra, PS-Jhalda, Dist-Purulia and 2. Sanjoy Keshri S/o-Not Known, near Sarbojanin Durga Mandir under Ward No-V of Jhalda Municipality, PS-Jhalda, Dist-Purulia under Sec-27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
