On 29.11.2017 at about 2.45 PM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Jiaur Rahaman Mondal, AE S&LP Unit, Purulia Regional Office, WBSEDCL 2. Sankar Chandra Mahato, LM, S&LP Unit, Purulia Regional Office, WBSEDCL 03. Dayamay Mahato, TSH, S&LP Unit, Purulia Regional Office, WBSEDCL 04. Ganesh Mahato, Gr1 TSH, Joypur CCC, WBSEDCL 05. Haragobinda Singh Mura, OE, Joypur CCC, wbsedcl entered the commercial premises (Shop) of Sri Sitaram Mahato, S/O- Lt. Chakradhar Mahato of village:- Srirampur (towards das more) P.S:- Joypur, Dist- Purulia and found Sri Sitaram Mahato was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his commercial premises (Shop) and connected load found 0.092 KVA.
