The above named complainant begs to state as follows :-

of accused no. 1 and their marriage was sojemnised on 02/12/2010 corresponding to 15th day of Agrahayan 1417 B.S. at village Jeladih under P.S. Joypur District Purulia and within the jurisdiction of this court. The said marriage was performed according to Hindu right and customs and according to the ceremonies prevalent in their community including exchange of garlends putting of vermilion etc. and the said marriage is still subsisting.





- 2) That at the time of marriage as per demand of the accused the father of the complainant had to pay a cash of Rs. 1,00,000/- along with other valuable articles and ornaments but the accused persons were not happy and satisfied with either cash or articles so given to the accused persons.
- 3) That after marriage the complainant was taken to her matrimonial home by the accused person and started to reside there as husband and wife with accused no. 1 along with other members in the same mess and house.
- 4) That in the meantime the complainant gave birth a male child namely sandip Kewat and there after gave birth another child namely Suraj Kewat.
- 2nd issue the accused persons started torture both physically and mentally upon the complainant and also demanded further dowary of Rs. 50,000/- but the complainant home for a good days.






- house it was the daily routine of the accused persons to inflict torture upon the complainant mercilessly and directed the complainant to bring Rs. 50,000/- from her father's house otherwise they will not alone the complainant to stay in their house.
- persons with common object and intention tried to put fire time on her body and there by poured kerosene oil on the body of the complainant and as aulted the complainant with a view to finish her life however her life was saved when their neighbouring people hearing the hue and cry assembled there.
- the complainant from their house giving out her that unless she brings Rs. 50,000/- she would not be allowed to stay at her matrimonial house in any further and since there after the a complainant is residing at her father's house at Jeladih with the help of the neighbouring people.
- 9) That on 20/08/2017 when the complainant was driven out from her matrimonial house all of her ornaments valued Rs. 1,00,000/- one lakh and other belonging stri-

dhan etc. which were kept and entrusted to the accused persons have not been handed over to the complainant over which the accused persons have no right at all.

- her paternal house at village Jeradih under p.S. Joypur all the accused person came there and after enter into the house they abused the complainant and assaulted her with fist and blow and after falling her on the ground and kicked her like a foot ball for which the complainant sustained seviour injury on various parts of her body and her left leg has broken. Having been the precaylous condition of the complainant from their clutches and hearing golmal the neighbouring people gathered and then the accused persons flad away.
  - 11) That the complainant is a helples lady having no income of her own and not in a position the continue her case at her own capacity.
  - 12) That the matter is very serious in nature and accordingly police investigation is required.
