


The above-named complainant begs to state as follows:-

1. That the complainant & the accused persons are the resident of same village

Within the Joypur P.S. and under the jurisdiction of this court.

2.That on 16.10.2017 coessponding to 29th Aswin,1424 B.S.at about 12.00 noon, Jahalu Mahato husband of the complainant had been making mud built wall within his land at that time suddenly the accused persons, Pravash Mahato, Gouranga Mahato, Netai Mahato, Helku Mahato, Budhu Mahato, Ludhu Mahato, Ranjit Mahato and Dhananjoy Mahato by forming an unlawfull assembly and armed with lathi and bricks, obstructed upon the said construction work. Then the complainant and his

husband protested, then and there accused Pravash Mahato, Gouranga Mahato and Netai Mahato threw bricks with a view to hitting the head of the complainant, as a result she sustained cut injury upon the scalp and profused bleeding and remaining accused persons namely Helku Mahato, Budhu Mahato, Ranjit Mahato and Dhananjoy Mahato ghearoud to them and assaulted the complainant and his husband by the help of lathi as a result the complainant fell down on the ground with bleeding condition. All the accused persons had been threatening to them by saying, "Aaj toderke mayre cess kore dibo ". Due to fear they shouted, then the co-villagers i.e. witness nos. 3 to 5 rescued them from further humiliation and any how the complainant her husband were saved and seeing the witnesses, the accused persons flade away.

3.That the witness no.3&5 brought the complainant & her husband to Darikuri P.H.C. for treatment and both were medical treated there but seeing the serious condition of the complainant,she was referred to the Joypur B.P.H.C. for better treatment and three stiches were done upon her scalp. And the doctor advised to the complainant for her C.T.Scan of brain &'X' Ray also.

4. That the complainant reported the matter in writing before Joypur p.s. but the police personnel did not receive the said written complaint ,then the complainant was compelled to report the said matter in written before the Superintendant Of Police, Purulia on 17.10.2017, but of no good.

It is, therefore, prayed that your Honour be pleased to send the -is petition of complaint to the O/C, Joypur, P.S., Purulia for investigation after treating the same as F.I.R.in U/S 156(3) Cr.P.C
