The complainant most respectfully beg to state :-

- 1. That the complainant is the permanent resident of Village
 Lohat under Kalidaha Gram Panchayet within the jurisdiction
 of Kashipur Panchayet Samity and the jurisdiction of your
 Honour's court as well.
- 2. That the complainant is by caste Santhal and belongs to Tribal community.
- 3. That the complainant is a very person so his name found placed in the B.P.L. List published by the authority concerned. Bearing B.P.L. No. 14-018-007-004/13863.
- 4. That the accused person is an elected pradhan of Kalidaha Gram Panchayet under Kashipur Panchayet Samity and still this date holding the past of Pradhan, Kalidaha Gram Panchayet.
- 5. That the authority concerned sanctioned a house under Indira Abash Yojona (I.A.Y.) for Rs. 75,000/- in the year 2013-2014 behind the knowledge of the complainant.
- that he has been sanctioned the afopesaid house and thereafter made contact with the Pradhan i.e. the present authorised par person several times. Who assured and promised to the complainant that his above stated house will be constructed and completed within time.







- 7. That in the above stated situation the complainant waited for a long time and latter on come to learn from on line, that his house has already been completed.
- 8. That it is to be further submitted that the sanctioned money was already been disbursed in a fake bank account of Banggiya Gramin Vikash Bank Indrabil Branch.
- 9. That from the above stated everment it is established and evident that the authority concern i.e. the B.D.O. Kashipur Panchayet samity disbursed the stated amount in persuance of the fraudulent and false information of the accused person and thus the accd. person has misappropriated made default-cation and embelzzeled the Government money.
- caused irreparable loss and injury to the complainant who belongs to S.T. community by giving false information to the B.D.O. who is non else but our important public officer and thus the accd. person committed offence under the provisions of I.P.C. and S.T./S.C. Prevention of Atmittees Act 1989.
- 11. That the complainant knocked the door of the various office but in no good, having no alternative lodged complainant before Kashipur P.S. and the S.P. Purulia inspite of that no frutful result has comeout hence the complainant has been compelled to come before your Honour's court.
