

In producing here with one Subhas Ch Mandal (59) S/O – Lt Guhiram Mandal of village Bhabanipur, PS- Kashipur, Dist- Purulia along with following seized articles viz-

- 1) 18 Liters (Approx) of country spirit contained in a plastic container
- 2) 100 grams (Approx) NISHADAL,
- 3) Four pieces of plastic glass &
- 4) Sale proceed of Rs. 95/--

I ASI Indrajit Sarkar of Kashipur P.S. do here by lodged a complaint against accd. namely Subhas Ch Mandal (59) S/O - Lt Guhiram Mandal of village Bhabanipur, PS- Kashipur, Dist- Purulia to the effect that today (18.11.17) at about 17.25 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Subhas Ch Mandal (59) S/O - Lt Guhiram Mandal of village Bhabanipur, PS- Kashipur, Dist- Purulia stocked country spirit illegally at his house at Bhabanipur village and selling the same to hike price for his personal gain. I informed the matter to O/C Kashipur PS and as per direction of O/C Kashipur PS, myself along with C/424 Naba Kr Sao and C/237 Gopinath Roy both of Kashipur PS rushed to the spot for holding raid by Govt vehicle. At about 18.15 hrs myself along with force reached at Bhabanipur village and held raid in the house of Subhas Ch Mandal (59) S/O - Lt Guhiram Mandal of village Bhabanipur, PS- Kashipur, Dist- Purulia and found that Subhas Ch Mandal was mixing the country spirit, contained in plastic Container, with some intoxicated substance(like white powder)having acrid smell which is likely to cause disability or death to human being, at his house at Bhabanipur village and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd Subhas Ch Mandal, and detained him. I asked him about the white powder like substance and accordingly, detained Subhas Ch Mandal recognized it as "NISHADAL" (approx. 100 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Subhas Ch Mandal (59) S/O – Lt Guhiram Mandal of village Bhabanipur, PS- Kashipur, Dist- Purulia and arrange for its investigation.
