



#### The above name complainant begs to state as follows:


- 1) That the complainant has his ancestral Bastu property under mouza Kenda P.S. Kenda, District Purulia and have has possessing the same all throughout, but presently the complainant is residing tat village- Bagda under P.S. Puncha as he got some landed properties therein and taking advantage to temporary absence of the complainant the accused persons who have their land to the adjacent East to the land of the complainant tried to encroach a portion thereof.
- 2) That on 02/11/2017 at about 11:00 AM when the complainant after receiving information visited the place he to his utter surprise noticed that the accused persons illegally tired to encroach a portion of his land and tried to

make boundary wall with the complainant protest then there was some hot exchange of words in between the parties.

- That after a few months when the complainant filling up 3) the pit upon his land made by the accused persons by forming unlawful assembly armed with deadly weapons criminally trespassed in the land of the complainant with a view to commit mischief and that the accused persons then abused the complainant and his family members in filthy languages and being protest made by the complainant the accused persons became very much furious and damaged some articles belonged to the complainant causing loss of Rs. 5,000/- and when the complainant protested then the accused persons assaulted him with the help of lathi and fist and blows causing injuries on his person, at the time of incident the accused persons also have taken away some wooden logs belonged to the complainant the value would be Rs. 20,000/-
- 4) That the complainant reported the matter of the local villagers as well as the Police and Panchayat Prahdan but none of them abele to compromise the dispute as the accused persons are very adamant in nature having no regard of those respectable personals.

5) That when the complainant raised alarm at the time of incident then the local people collected there and witnessed the incident.

That the complainant thereafter lodged one complaint to the local P.S. and when no legal action was taken by the said Police then another complaint was lodged to the superintendent of Police Purulia but same fate. Hence the complainant is under compelling circumstance filed this complaint before this Ld. Court under the law.

In the circumstances it is therefore, prayed that your honour may be pleased to send the petition of complaint to the Officer-in-charge, Kenda P.S. treating the same as FIR under section 156(3) for investigation.
