In producing herewith the accused Rambilash Tantubai (22) S/O-Lalchand Tantubai of Vill - Kumardi P.S. - Arsha, Dist - Purulia, before you and with one improvised fire arms having 10.5" inch length (Approx.) iron Butt, firing pin ,and trigger as working condition with one live cartridge sealed and labeled which were seized from his exclusive possession. I, SI Banshi dhar Mukherjee of Kotshila PS am to state that Today (08.11.17) received a secret source information that the above noted person being possessed with an improvised pipe gun is moving suspiciously near a bridge (Kasai Bridge) on Chotohankal - Sambalpur road. By informing O/C Kotshila P.S.I diarized the fact in G.D, this refers to Kotshila P.S GDE NO-303 dt 08/11/2017. On getting the tip off, myself along with 1) C/223 Jiban Mahanty 2) C/705 Jagadish Mahato rushed to that place, to work out the information. This refers to Kotshila P. S GDE No. 305 dt 08/11/2017 and C.C No- 3371/36.17. On arriving there, and kept the Govt hired vehicle bearing no WB- 55A/3868 in a distance ,at about 20.45 hrs, found that the above noted person is waiting near the said bridge. On seeing the police party, he tried to fled out from that spot somehow being assisted with C/223 Jiban Mahanty & C/705 Jagadish Mahato I can able to apprehend the above-mentioned person. searched him in presence of the witnesses and found one Improvised Fire Gun loaded with one live cartridge from the back waist of that person. I safely took out the gun from his waist and unloaded the gun safely. So none local witnesses available during making the seizure. So I took Rambilash Tantubai (22) S/O- Lalchand Tantubai of Vill -Kumardi P.S. - Arsha , Dist - Purulia, in custody and the seized fire arms and ammunition as alamat and bought him in PS and produced before you.

Under the above circumstances I am pray before you to start a specific case under proper section of law against Rambilash Tantubai (22) S/O- Lalchand Tantubai of Vill – Kumardi P.S. – Arsha , Dist – Purulia, and obliged.
