





> The humble petition on behalf of above-named Complainant/ petitioner

Most respectfully Sheweth :-

- 1. That the complainant and the accused persons all are permanent residents of village Gopalnagar within P.S. Manbazar within district Purulia and within the jurisdiction of this court.
- 2. That the complainant is the owner of 5 decimals of land recorded in R.S. Plot Nos. 515 of Mouza Gopalnagar within P.S. Manbazar and is in actual physical possession over the same.
- 3. That the complainant has purchased the said land recorded in R.S. Plot No. 515 measuring of an area of 5 decimals situated at mouza Gopalnagar within P.S. Manbazar from the rightful owner by registered deed of sale vide deed no. 5285 dated 31.12.1979. In an amicable partition in between the co-sharers of the plot, the complainant got 4 decimals of land in R.S. Plot No. 515. After such partition the complainant made improvement of his land and also demarcated his 4 decimals of land by 8 numbers of cement Pillars. The total cost of 8 Pillars is Rs.8,000=00. The said land also has been recorded in the name of the complainant in the L.R. Record of right in L.R. Khatian No. 677 of mouza Gopalnagar. The the complainant has valid right, title, interest and possession over the land.
- 4. That on 25.8.2017 at about 9 A.M. the complainant found that some persons of his village namely 1. Kalachand @ Bouridas Karmakar, 2. Kanai Karmakar, 3. Balai Karmakar, 4. Madhab Karmakar, 5. Biswanath Karmakar, all Sons of late Bhaddeshar Karmakar, all are resident of Village & Post - Gopalnagar, P.S. Manbazar, District Purulia most illegally and wrongfully entered into his land and removed all the pillars illegally from his land and also took away the same in their house. The said persons are very dangerous in nature and having found their adamant attitude the complainant could not protest against their illegal aet as because previously they gave out life threat to the complainant.



5. The said persons have got no right to enter into the land of the complainant and have got no right to take away the pillars from his land, but inspite of that they took away the same and have committed offence.

- That the complainant lodged written complaint before the Officer-in-Charge of Manbazar P.S. on 25.08.2017 but the Police did not take any steps in the matter till date.
- 7. That as no action was started and/or no specific case was started against the accused persons, the complainant ultimately submitted a written complaint in the Office of the Superintendent of Police, Purulia on 4.09.2017 but although a reasonable time period has elapsed since there after but no effective step has been taken as yet the complainant has been compelled to take recourse to this learned Court.
- 8. That the accused persons have committed criminal offences for which they are liable to be punished in accordance with law.
- 9. That the complainant is a retired service holder and a senior citizen, he is unable to bear the day to day expenses of a complainant case. The delay towards filling the case has been caused due to the reasons stated in the preceding paragraph and the same may be condoned

It is, therefore, prayed that your honour would graciously be pleased to send this petition of complaint to the Officer-incharge of Manbazar Police Station with a direction upon him to investigate the case under section 156 (3) of Cr. P. Code treating the petition of complaint as F.I.R.
