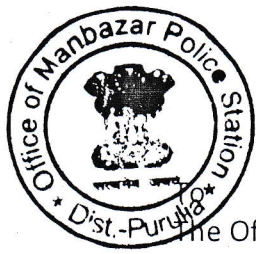

- 4) Two yellow colour medium size bag.


I ASI Santosh Sardar of Maanbazar PS beg to state that today on 07.11.17 at 16.35 hrs receive a telephonic information for reliable source that Laltu Mukherjee (30 years) s/o Chitarajan Mukherjee of vill- Natundih Ps- Indpur Dist- Bankura was stocked illegally and selling country spirit the same to hike price for his personnel gain at burisahar then I noted this information in GD vide manbazar Ps GDE No-227 dated 07/11/17 then I informed O/c manbazar Ps and as per direction of O/c Manbazar Ps myself along with C/-749 Jaladha Kaibortya and C/-74 Kamakhya Prasad mandal of manbazar Ps rushed to the spot for raid by Govt. Vehicle. At about 17:15 my self along with force reached at Burisahar and hold raid near at burisahar on Pairachalli Manbazar road and found said Laltu mukherjee was selling liquor in his shop and seen the police party some person fled away and said Laltu Mukherjee tried to conceale himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid paper for selling country spirit but he failed to produce any valid document s/ license for possessing / selling the same, so I seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses. I arrested the above mentioned accused person namely Laltu Mukherjee.

Hence I there for pray that a specific case may kindly be started against arrested accused person namly Laltu Mukherjee (30 years) s/o-Chitarajan Mukherjee of vill- Natundih Ps Indpur Dist- Bankura .
