I ASI Rabin Mukherjee beg to state that today on 07.11.17 at 17.35 hrs while I was in evening mobile patrol duty, I received an information from a reliable source that one santosh mondal (46 years) s/o-Dharanidhar mondal of vill-badra Ps-Puncha Dist-Purulia was stocked country spirit illegally and selling the same to hike price for his personnel gain at burisahar then I along with C/ 244 Krishnapada Mukherjee and C/ 1391 Jayanta Panda rushed to the spot for raid by Govt. Vehicle. At about 18:15 my self along with force reached at Burisahar and hold raid near at Rupali Hotel on Pairachalli Manbazar road and found said Santosh Mandal was selling liquor in his shop and seen the police party some person fled away and said Santosh Mandal tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid paper for selling country spirit but he failed to produce any valid document s/ license for possessing / selling the same, so I seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses. I arrested the above mentioned accused person namely Santosh Mandal.

Hence I there for pray that a specific case may kindly be started against arrested accused person namely santosh mondal (46 years) s/o-Dharandhar mondal of vill-badra Ps-Puncha Dist-Purulia .
