Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sudip Murrem S/O-Late Ramswar Murrem of Village- Sukhapata, P.O- Pirongoria, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 22.11.17 at about 03:58 PM, Sri Bijan Suari, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Mritunjoy Mandal SAE (E), Manbazar CCC
- 2) Somenath Laha LM, Manbazar CCC

entered the premises of Sudip Murrem, S/O-Late Ramswar Murrem of Village- Sukhapata, P.O- Pirongoria, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisedly by direct hooking through WBSEDCL's LT line.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Two bulbs (100Watt and 60Watt)
- 2) One Fan (60Watt)
- 3) One LED bulb (9Watt)
- 4)

out of which we seized the following -

- 1) Two core PVC wire (Approx 17mtr)
- 2) Hooking device
- 3) one bulb - 60Watt

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 04:05 PM on dated 22.11.17. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
