The humble petition on behalf of the  
Petitioner / Complainant,

Most respectfully begs to state:

- 1) That your Complainant is the Divorcee wife of the Accused Prasenjit Ray, their marriage was solemnized on 02/12/2009 as per Hindu Law and customs at Bhagabandh Para Purulia, P.S. Purulia (T), District Purulia, after marriage your Complainant came to the house of the Accused at Vill. Narayanpur, P.S. Neturia, Dist. Purulia and live together as husband and wife, and the same was duly consummated and out of their wedlock a male child has born on 16/09/2011.
- 2) That since and after the birth of the said male child the Accused started all sorts of physical as well as mental torture upon the Complainant persistently.

3) That on 20/10/2011 the Accused assaulted your Complainant and drove her out from his house and since 20/10/2011 your Complainant and her minor child is residing at her father house, Bhagabandh Para Purulia.

4) That at the time of marriage of your Complainant with the Accused Person, the father of your Complainant gave and gifted the following articles to her daughter/ Complainant and cash Rs.75000/- and ornament to the Accused and after marriage your Complainant took and kept these articles as mentioned below in the house of the Accused Person at Vill. Narayanpur, P.S. Neturia, District Purulia as 'SRTRIDHAN' properties and the Accused took charge of those properties and kept in his custody on condition that, the articles would be handed over to the Complainant as and when required.

5) That due to persisted torture of the Accused your Complainant was compelled to file a Divorce Suit being Mat. Suit No. 127 of 2013 before the Ld. District Judge, Purulia and the said was decreed as exparte against the Accused / husband on 26/03/2014 , U/S 13 of Hindu Marriage Act.

6) That there after your Complainant on several occasions approached the Accused verbally to return these articles to your Complainant and the Accused agreed to return the articles as mentioned below.

7) That lastly on 24/05/2017 your Complainant again approached the Accused to return the same but the Accused flatly refused to return

the same articles in violations of the verbal agreement and assurance which total amounts to breach of trust contract.

8) That your Complainant sent one legal Notice to the Accused with a prayer for return of these articles including the dowry money on 30/5/2017 but no reply has been given.

9) That there is a prima facie case of Criminal breach of trust as well as cheating against the Accused who has also misappropriated the articles punishable in accordance with law.

10) That the following articles belonged to the Complainant are still lying in the house of the Accused Person and there is every chance of recovery of these articles from the possession of the Accused Person.

11) That your Complainant reported the matter to the O/C Purulia (T) P.S. as well as the Superintendent of Police, Purulia but no good.

It is therefore prayed that your Honour be pleased to send this Complaint Petition to the O/C Purulia (T) P.S. for investigation after treating same as F.I.R. in Under Section 156(3) Cr.P.C. for the ends of justice.
