Sub: Prayer for starting a specific case u/s 46 A(c) B.E. Act, 1909.

Respected Sir,

In producing herewith one accused person namely Kali Prasad Mondal (42) S/O- Subal Mondal of village Benipur, PS-Neturia, District- Purulia with seizure of (1) 20 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml each and (2) 05 pcs sealed bottles of Dil Khush country spirit containing 600 ml each were seized under proper seizure list.

I beg to submit that today (26.11.17) in between 19.05 hrs to 19.35 hrs. a raid was conducted behind Samar Misti Mahal at Benipur under Neturia PS, Dist- Purulia on acting upon a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that accused Kali Prasad Mondal (42) S/O- Subal Mondal of village Benipur, PS-Neturia, District- Purulia was keeping / selling liquor which were kept in bushes behind the shop, on demand Kali Prasad Mondal failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he has committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also seized (1) 20 pcs. Sealed bottles of Dil Khush country spirit containing 375 ml each and (2) 05 pcs sealed bottles of Dil Khush country spirit containing 600 ml each under proper seizure list duly signed by witnesses and accused and labeled at the time of arrest. During arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Kali Prasad Mondal (42) S/O- Subal Mondal of village Benipur, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/207 Dilip Kumar Paul (2) C/420 Sk. Chand and (3) C/1304 Dhananjay Mondal all of Neturia PS accompanied me vide Neturia PS CC No-3595/17 Dt. 26/11/17.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Kali Prasad Mondal (42) S/O- Subal Mondal of village Benipur, PS-Neturia, District- Purulia under proper section of law.
