Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **ISMILE ANSARI**, S/O- Idrish Ansari of Village- Bhalagora, P.S.-Para, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 27.11.2017 at about 11.10AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Mr. Avishek Das, SAE(E), Dubra Para CCC, Mr Lakkhan Mahato, LM, Dubra Para CCC, Bilash Ch Mahato, GM TSH, Dubra para CCC, Manmatho Mahalli, Sr.TSH, Dubra Para CCC, Pagal Ch Mahato, TSH, Dubra Para CCC, and Sanjoy Prasad, Sr.TSH, Dubra Para CCC inspected the premises of **ISMILE ANSARI**, S/O- Idrish Ansari of Village- Bhalagora, P.S.-Para, Dist Purulia WBSEDCL. During inspection it was found that the said **ISMILE Ansari** was enjoying electricity unauthoritarily by direct tapping of service cable as hooking arrangement from WBSEDCL's near by service line and for running his 05 nos CFL, 03 nos Ceiling fan, 02 nos Bulb, 02 nos TV, 01 nos AC, 01 nos F.W for domestic purpose, which is an offence u/s. 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labour is preparing to remove it from site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 11.45AM.

As such, it is requested that you **ISMILE Ansari** of Village- Bhalagora, P.S.- Para, Dist-Purulia has committed an offence of theft of electricity under section 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of the said electricity treating this complaint as F.I.R.
