Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **SK TAJIMUDDIN, S/O- SK AJIM of Village-Sankra B, P.S.-PARA, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 27.11.2017 at about 1.15PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with MR Avishek Das, SAE(E),Dubra Para CCC, MR LAXMAN MAHTO SR LINESMEN, Mr Sanjoy Prasad, TSH, Dubra Para CCC, Mr Bhaktipada Mahato, TSH, Dubra Para CCC and MR BILASH CH MAHTO HR GRI TSH ,Dubra Para CCC inspected the premises of **SK TAJIMUDDIN S/O-Sk Ajim of Village- SANKRA B, P.S.-PARA, Dist Purulia**. During inspection it was found that the said **SK TAJIMUDDIN** was enjoying electricity unauthorizedly by direct Tapping/Hooking of service cable as hooking arrangement from WBSSEDCL's nearest low tension over head line for running his 01 no 60watt bulb,01 no 60watt FAN, approx load 0.120 KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSSEDCL. The inspection team left the site at about 1.32PM.

As such **SK TAJIMUDDIN, S/O- SK AJIM of Village-SANKRA B, P.S.-PARA, Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
