Sir,

With due respect I the under signed would like to inform you that one Ranjan Kumar Mandal, head Master of Dubra School (H.S), a government employee has misused his power which he is holding in his official capacity and utilized such power for personal gain, he has forged signature and misappropriated amount of various funds of the Dubra High School (H.S) that were allotted by the government to Dubra High School (H.S) and has done lot of financial irregularities and has taken whimsical decisions exceeding the mandates of the West Bengal Council of High Secondary Education and acted contrary to the norms of the managing Committee of the school. To suppress the financial irregularities done by the above named **no financial audit of Dubra High School (H.S) was conducted in the financial year 2015-2016, 2016-2017** which is not at all acceptable.

For that the managing committee has issued show cause letter to the above named, dated 21-08-2017.

The reply to the show cause letter given by the above named was not satisfactory. After going through the books of account on 14-09-2017 that was present in the school the managing committee has inquired and found that the accounts are incomplete and does not reveal the actual position of **Mid Day Meal Fund , Examination Fund, Development Fund, Remedial Classes Fund** and there is no supportive authentic Vouchers of expenses incurred from those funds and the utilization certificate submitted to the D.P.O office Purulia for expenditure for remedial classes held on 1st Sep 2016 to Dec 2016 differs from the documents that was presented before the Managing Committee on 10-08-2017 and its continuation on 12.08.2017. The vouchers that was presented by the above named has been signed by himself in various styles of signatures (forged). Double vouchers were presented for single expenditure. The students of remedial classes were not provided with exercise books, pencils, pen etc. and the teachers who took remedial classes were not provided Tiffin for refreshments though vouchers for these expenses has been submitted and reasons for doing so has not been explained by him.

In this way the above named Ranjan Kumar Mandal being a government employee has committed forgery, misappropriation of funds, criminal breach of trust by government servant and has done cheating with the knowledge that wrongful loss may ensue to Dubra High School (H.S) whose interest he is bound to protect.

To protect the interest of the school, please take appropriate legal action against Ranjan Kumar Mandal according in Indian penal Code.
