I do hereby record this case as suomotu against arrested accd Prabodh Mahato @ Falari (33 yr), S/O Madan Mahato of vill Delang, PS Pancha Dist Purulia, to the effect that today(5.11.17) at around 21:45 hrs in course of my mobile duty at PS area I received a telephonic information from my source that one tractor was carrying sand illegally through Dhelang . Accordingly myself along with my accompanying officer and forces rushed to the spot and at Dhelang More I found one Tractor was coming towards Bhutam Side. I intercepted the tractor and found the tractor having No WB 37TC-0222 was tagged with a trolley bearing NO WB 39 TC- A/14 being loaded with sand, two shovels and two dhamas . on asked the driver revealed his identity as Prabodh Mahato @ Falari (33 yr), S/O Madan Mahato of vill Delang, PS Pancha Dist Purulia, But on demand he failed to produce any papers of the vehicle and he confessed that he lifted the sand from the bank of river Kangsabati at Dhaddkidih Ghat which is not a registered ghat and he lifted sand from that ghat only to escape from the govt revenue and hence he could not produce any challan. He also failed to produce any identity proof and even D/L and there is every ground to believe that he procured the tractor and the trolley either in fraudulent means or by means of theft. Hence I seized the tractor Mahindra Model No. B275DI TU MKM DLX bearing No WB 37 TC -0222, Engine No- RHE2EAN5836 and Chassis No MBNABAEAKHRF01237 was tagged with a trolley bearing NO WB 39 TC- A/14 being loaded with sand to the brim, two shovels, two dhamas under proper seizure list from 22:35 hrs to 23:05 hrs and after seizure I arrested him observing all the formalities regarding arrest. As the punishment of the offenses he committed is less than 7 yrs yet I arrested him for the purpose of proper investigation and to ensure his presence in the Ld Court as his identity could not be verified. I also issued Check list.

So I do hereby record Pancha PS Case No 46/17, dtd 05/11/17, U/S 379/411 IPC and section 21(4) of the Mines and Minerals (Regulation and Development) Act 1957 and directed ASI Biswarup Roy to investigate the Case.
