

The humble Petition on behalf of the Complainant - Shri Fatik Mahato, most respectfully begs to state as follows :-

 That, the Complainant is a very poor person and most of the days he alongwith his family members had to got out of his house for search of work and for his livelihood.



- That, the Complainant is having his family consisting of his wife namely Smt. Chinta Rani Mahato and his minor daughter namely Sima Mahato.
- 3. That, my daughter Sima Mahato was reading in Class-IX in Lakhra U.N. High School, P.S. Puncha, District -Purulia (West Bengal). That my daughter was born on 05-09-2001 and as such my daughter - Sima Mahato is aged about only 16 years.
- 4. That, on 27-07-2017, corresponding to 10th day of Shraban, 1424 B.S., your Petitioner alongwith his wife went out of their house in search of work as a Daily-Labour. Their daughter Kumari Sima Mahato was alone in their residentical house situated at Village-Pakbirra within P.S. Puncha, District Purulia (W.B.)
- 5. That, on returning back your Petitioner did not find their minor daughter - Sima Mahato in their house, as such, they started searching of their daughter in their village and in the surrounding villages at the houses of their relatives and friends but they did not find their daughter anywhere.
- 6. That, finding no other option, your Petitioner has been to the local Puncha Police Station and lodged a missing Diary orally.
- 7. That, subsequently Dhananjoy Mahato of their village

informed that some of the villagers namely Sandip Karmakar, Son of Shri Santosh Karmakar, Shri Santosh Karmakar, Son of Late Mayur Karmakar, Smt. Somi Marmakar, Wife of Shri Santosh Karmakar, Kalyani Karmakar, Daughter of Shri Santosh Karmakar, Mitan Karmakar, Son of Late Lakhu Karmakar, Subodh Karmakar, Son of Late Ram Karmakar, had forcibly entered into the house of the Complainant and after assaulting Sima Mahato she was forcibly taken away from her father's house.

- 8. That, Sima Mahato has been abducted by the above named accused persons with the intention of compelling minor Sima Mahato to marry with Sandip Karmakar, Son of Shri Santosh Karmakar of Village Pakbirra and forcibly intercourse with her without her consent. She has been kidnapped and/or **min** abducted from the lawful Guardianship of the Complainant on the offences of Sexual assault upon the minor girl Sima Mahato.
- 9. That, the minor Girl Sima Mahato should be protected from such type of sexual offences committed upon the Victim girl Kumari Sima Mahato by Sandip Karmakar and other accused persons who hwe instigated the Principal Accused - Sandip Karmakar to commit the

offences.

- 10. That, the Complainant has come to know from the reliable sources that her minor daughter Sima Mahato has been abducted by the accused persons and kept unlawful detention at Debnagar Basti, Jamshedpur, P.S, Mango, District Singhbhum(East), Jharkhand.of the minor girl Sima Mahato under the age of 16 years for unlawful purposes and/or sexual offences upon the minor girl and she may be compelled to sexual exploitation in illegal manner with other persons and she may be used for purpose of prostitution and she may be induces to fo ced or seduced to illicit intercourse with another person. So it is crystal clear that the minor girl Sima Mahato has been kidnapped and kept in x detention in confinement at Jamshedpur, Debnagar Basti under Mango Police Station within the district of East Singhbhum, Jharkhand.
- 11. That, the Complainant had been to Puncha Police Station on several times but every time the Police has denied to lodge (the complaint against the accused persons and has advised the Complainant to take shelter before the Court of Law, as duch this Petitioner filed this Petition UndersSection 156(3) Cr.P.Code to lodge an F.I.R. against the above names Accused Persons for traal before the Ld. Court. It is also mentioned that the Complainant had been to the Superintendent bf Police, Purulia and Contd - P-6.

filed a Complaint Petition against the Accused Persons above named. But till today no action has been taken against the Accused person by the Police.

That, as your Petitioner is a very poor person, 12. as such, he cannot pull the case at his own costs so a Police case is necessary for taking action against the above named Accused Persons for committing Criminal Offences and Sexual assault on various ways upon the minor girl Sima Mahato.

It is, therefore, prayed that your Honour may be graciously pleased to pass an order directing the O.C. of Puncha P.S. for treating this Petition ata - 6/11/12, U/s- 363 (365 9 PC as an F.I.R. Under Section 156(3) Cr.P.
