filthy language. The Complainant came out from his house and he raised objection against the illegal activities of the Accd. Persons, than all the Accd. Persons became angry and they started to assault the Complt. mercilessly by fist and blows and also by Lathi on the different parts in the bodies of the Complainant and on a result of which the Complt. sustained gravisous injuries on his body and he fell on the ground. There after all the Accd. Persons took away sum of Rs.3000/- from the pocket of the Complt. The Complainant raised alram by saying Bancho Bancho, hearing the noises the witnesses named above came by the spot and they saved the life of the Complt. from the hands of the Accd. Persons. There after the Accd. Persons fled away from the P.O. The Witnesses named above saw the incident and the matter was also reported to them.

2) That there after the Complt. went to the Pancha P.S. with the help of the Witnesses and he reported the matter to the Police.

The Complt there after went to Pancha B.P.H.C. for his treatment. Where he treated there as a O.P.D. Patient. The Police of Pancha P.S. did not take any steps against the Accd. Persons due to the pressurá of the ruling

Political Parties. The Complt. also reported the matter to the S.P. Purulia on 29/07/2017 but till today the Police of Pancha P.S. did not start any specific case against the Accd. Persons .The Accd. Persons are still now treating to the complt. in a dire consequences.

3) That the Accd. Persons have committed offences U/S 147/148/379/323/325/506/34 I.P.C. and they should be punished accordingly.

4) That the Complt. is a poor man and he has not means to conduct the case in personal capacity and there is question of search and seizure so far the ends of justice the Police case of required.

It is therefore, prayed that your Honour may be graciously pleased to sent this petition of complaint before the O/C Pancha P.S. treating the same as F.I.R. and to investigate the case of provided U/S 156(3) of Cr.P.C.
