I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Jagadish Das S/O Lt. Hari Das of Vill - Siholi, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 01.11.2017 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E), & Tapan Kumar Rajwar, L.M. of Telkalpara CCC, WBSEDCL conducted a raid programme at village Siholi under Purulia(M) P.S. When our team at about 02.00 P.M. entered to the Domestic premises of Jagadish Das, we found that he was enjoying electricity dishonestly by means of Direct Hooking from nearest LTOH Line and run Pump Motor set & Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 02.30 P.M. after completions of inspection & necessary formalities.

Jagadish Das S/O Lt. Hari Das of Vill - Siholi, PS-Purulia(M) has committed theft of electricity under section 135(1)(a) of the Electricity (Amendment) Act-2007.
