In the matter of an Application u/s 156 (3) Cr.P.C.

The Complainant named above begs to state as follows:-

- 1) That the Complainant along with his elder brother i.e. the Witness no-2, runs a Garments Shop under the name and style of "Tumpa Bastralaya' situated at Sindri Chas Road, P.O-Sindri, P.S-Purulia(M), Dist-Purulia which is under the Jurisdiction of Your Honour's Court. Beside the same, the Complainant also runs a 'Brick Kiln' at Garafusru under Purulia(M) P.S. and deals in the sale and manufacturing of Bricks.
- 2) That the Complainant has filed a Suit for Damages for Defamation against the Accused Person Padma Lochan Mahato vide Money Suit no-04/2017 which is still pending in the Court of the Civil Judge, Senior Division, Purulia. After getting such news about filing of the suit, the Accused Person on several occasions threatened the Complainant and his family members. The Accused often used to threaten the Complainant of dire consequences over telephone and is also creating persistent pressure upon the Complainant and his family members to withdraw the suit against him.
- 3) That on 28/09/2017, corresponding to 11th day of Aswin, 1424 B.S. at about 4 p.m. the Complainant along with the witness no- 3 who happens to be the staff of the Complainant, were busy in his shop with their customers of whom one was Witness no-4. All on a sudden the Accused Person being accompanied by some of his relatives, friends and some other unknown persons, all being armed with Lathi forcibly entered into the shop of the Complainant and in a rowdy mood asked to the Complainant to withdraw the Suit immediately. The Complainant, his staff and the customers tried to protest against the same, then the Accused Persons started assaulting the them by Lathi, fists, blows and kicks. They also started ransacking all the garments of the Shop of the Complainant. They also threatened the





Complainant of dire consequences and started abusing the Complainant and his staffs with some abusive languages. The Accused Person and his companions also held out threat stating that if the Complainant does not withdraw the suit, they will kill the Complainant and his family members and also will set his shop in fire and will implicate them in various false cases.

- 4) That at the very time, the Witness no-2, who happens o be the elder brother of the Complainant, reached the shop and tried to rescue the Complainant and his staffs from the clutches of the Accused Persons but they also started assaulting him mercilessly by fists and blows. The Accused Person and his companions thereafter placed some blank stamp papers and some blank white papers before the Complainant and his elder brother and asked them to put their signatures thereon. The Complainant and his elder brothe: out of fear put their signatures on the very papers as demanded by the Accused Persons. The Complainant apprehends that the Accused Persons may dishonestly use those blank papers signed by the Complainant and his elder brother for manufacturing any false documents and may use the same against them. The Accused Person then forcibly took away Rs.5,000/- from cash box of the Shop of the Complainant. They openly held out threat to the Complainant and the Witnesses by saying that they will soon put the Complainant and her other family members in much more dire consequences.
- 5) That the Complainant, his staffs and the Witness no-2 sustained various injuries over their persons due to the assault by the Accused Persons as stated herein above.
- 6) Thereafter the Complainant on that day informed the matter to the Police of Purulia(M)P.S. and accordingly the Police Personal at Purulia(M) P.S. who was on duty at the relevant time assured him that they will take appropriate step against the Accused Persons. But as no step was taken by the Police, the Complainant on 13/10/2017 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition II/S 156(3) Cr P.C. before Your Honour's Court.
- 7) That the Accused Persons have thus committed offences punishable u/s 147/323/342/427/379/448/506 I.P.C.
