In producing herewith one Nunaram Gorai (31 yrs) s/o Dulal Ch Gorai of Vill-Herodih, PS- Arsha, Dist- Purulia, along with seized articles - (1) one improvised single shooter country made pipe gun (firearm) along with one round of 8 mm ammunition. I ASI- Sukhendu Mondal of Purulia (T) PS do here by lodge complaint that, on 04.11.2017 at 20:25 hrs while myself along with C/558, Bifal Ch Mudi, C/1124, Dhirendra Nath Goswami of Purulia (T) PS with Govt. vehicle No. WB 56C 5421 were performing anti crime mobile duty, found a person was moving suspiciously at Sadhudanga under Over Bridge, Ward No 16, PS- Purulia (T) PS, Dist- Purulia. Seeing the Police party he started to flee away. However, we the Police party could manage to apprehend him who on interrogation disclosed his name and address as noted above.

On search of the person of said Nunaram Gorai, found one improvised country made firearm loaded with one round of 8 mm live ammunition kept concealed on the left side waist under his wearing full pant covered by wearing shirt in his exclusive possession. On demand he failed to produce any document/authority for possessing and carrying such firearm & ammunition.

Accordingly, I seized the same after preparing a proper seizure list duly signed by my accompanying Police Force as well as I got it signed by the arrested person also and also duly labeled. As the place is lonely, none was available to stand as witness of the fact.

As the accused person under such circumstances committed an offence U/S 25(i)(a)/27 Arms Act, so I arrested him after disclosing his ground of arrest after issuing arrest memo etc.

I, therefore, pray that, a case U/S 25(i)(a)/27 Arms Act may kindly be started against the above noted accused person and also for arranging its investigation.
