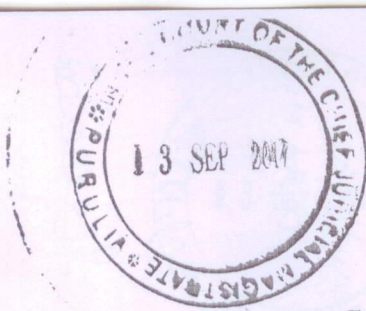

Most Respectfully Sheweth : -

- 1) \_\_\_\_\_ That the Complainant is the legal married wife of Sanjib Dutta Mudi and the marriage was solemnized on 13.12.16 at Purulia and within the jurisdiction of the Ld. Court. At present the Complt. is now residing in the care of her father at Napit para, Purulia.
- 2) \_\_\_\_\_ That as per demand of the accused persons, the father of the Complt. had to give a sum of Rs.3,00,000/- (Rupees Three Lakhs) only in cash; 150 Grams of Golden ornaments, Silver ornaments, Utensils, furnitures etc. to the accused persons in presence of relatives.
- 3) \_\_\_\_\_ That after completion of marriage, the Complt. was taken to Dubrajpur on 14.12.16 and on that day in the evening the complt ~~xxx~~ was teased by her husband and accused persons including some relatives that the father of complt. have not given the adequate dowry of Rs.1,00,000/- ( Rupees one lakh ) only to purchase motor-cycle . When the Complt. expressed her inability in making payment of additional dowry , then the complt. was ~~xxxxxx~~ badly assulted by accused persons.
- 4) \_\_\_\_\_ That it was noticed by the petitioner that the nature, character , attitude , habits etc. of the accused No.1 is not good. When the Camplat. Changed her clothes the accused no.1 snapped some photos, showing the photos

the accused No.1 threatened the complt. to make payment otherwise he will posted the photos. The Complt. protested but accused No.1 was very adamant not supply sufficient fooding and confined the complt. on the boundary of their residence.

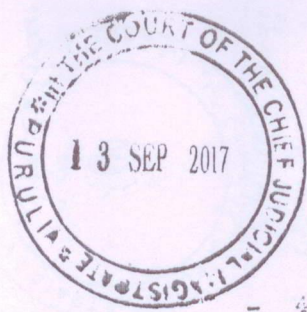
5) \_\_\_\_\_ That the Complt. had to allow all such torture and mental pain with the hope that accused persons will change and happy days will come. As per advise of the parents of Cimplt. she did tolerates but it was in vain.

6) \_\_\_\_\_ That the petitioner was subjected systematic mental and physical humiliation and she became the eyesore of husband and others, the petitioner was threatened by the husband and other not to disclose the matter to outsiders.

7) \_\_\_\_\_ That during stay at Dubrajpur, the husband used to press the neck of the complt. with an intent <sup>to</sup> the murder and pressed the mouth by Pillow as per abetment of other accused persons while the complt. was sleeping but the Complt. saved herself.

8) \_\_\_\_\_ That the atmosphere in the matrimonial home across the limit and the husband and others used to harras, abusive filthy languages and beyond tolerance. On 7.2.17 the Complt. was badly assulted by the

accused persons due to non fulfilment the additional dowry and threatened the complt. with dire consequences by saying - "তোমার স্বামী তোকে না পিসে ডিঙায় কতবে"

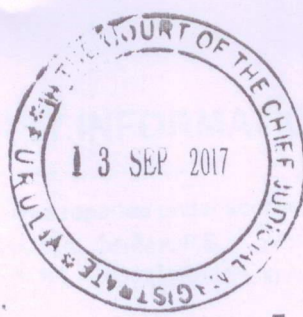
The complt. informed the matter to her father and others. On 10.2.17 the mother, uncle and aunt went to Dubrajpur. They were also threatened due to non fulfilment of Rs.1,00,000/- ( Rupees One Lakh ) only . The accused persons abused filthy languages and on that day the complt. was driven out from their house. The valuable articles are in the custody of Alo Dutta Mudi and husband . There is every chance of misappropriation of the said articles. The articles are " stridhan " .

9) \_\_\_\_\_ That the complt. lodged a Complain at "KALAMATI"

The Officer called the Complt. on 20.8.2017. The accused persons were present on that day. They disclosed that the accused persons No.1 is ready to file a mutual Divorce suit and create pressure upon the complt to put signatures on the plain papers when the complt. denied the accused persons threatened the complt.

When the complainant was proceeding towards her house, the accused no.1 and 2 unknown persons restrained the complt. near Gosala Railway Line threatened her not to lodge any complain at P. S. or elsewhere. The accused person No.1 tortured the complt. mentally and physically too.
