Sir,

This is to inform you that to-day (25.11.17) at around 08.30 P.M. myself with Svi Dinesh Mall, my younger brother went to Purnia Rly. platform to see off some prominent doctors hailed from out-sides to attend a health camp organised by Rotary Club - Purnia at Rotary Hospital Campus after parking our vehicle no. WB. 56 G / 18001 near the Rly fencing. Driver Swaga Charan was near the car. He informed us at the platform that one Indica car had dashed against our car ~~from~~ while it was taken on back at the same site causing damage to the front of our car. Our driver at once took the key of the said car as a mark of protest and soon after informed us the fact. At once we rushed to the spot and found our parked car was badly damaged. As the key of the offending Indica was taken out they used a group of persons about 20/25 in number turned furious and started using abusive languages towards us and pelted us with stones. They were not ready to listen to us and started assaulting me and my brother Dinesh Mall mercilessly with fists and blows successively when we fell down. Nevertheless they

They did not spare us and started kicking us. The mob prompted the assailants to kill us. Despite our repeated request to stop such inhuman and murderous assault on us, they did not desist from such assault as a result of which we suffered severe injuries on our persons. My brother sustained fracture injury on his left hand and we both somehow could be rescued by some other persons assembled there and we then with the help of others reached Purnia Sadar Hospital and got ourselves treated in the outdoor emergency. My brother having severe fracture injury has been hospitalised while I was released after first aid. Out of the total 20/25 assailants, we recognised Vinode Tewary of Purnia Poon as the man taking active part in such brutal assault. We shall be able to identify the rest assailants if shown.

The assailants thus assaulted us brutally in order to kill us and they intimidated us when we were rescued by others.

Kindly start a case against the assailants including said Vinode Tewary and contemplate legal action against them to meet the end of justice.
