His kind attention is drawn to the fact that on 25.11.2017 night (approximately 10.15 p.m.) our Night Guard Shri Nemai Banerjee was discharging his duties in the office premises of the Additional District Magistrate & District Land & Land Reforms Officer, Purulia at Raghapur with Shri Subodh Chakraborty, N/G & Asit Lohar, N/G. As construction works as well as electrification works are going on in the said office, agencies have engaged some workers for the said work. There is one recreation club in the office of the ADM & DL&LRO where six workers were present at night on 25.11.2017. Altercation cropped up suddenly between our Night Guard Shri Nemai Banerjee and that six workers at about 10.15 p.m. regarding opening the main gate of the office. The workers were frequently using the main gate at night. Our employee (Night Guard) declined to give the key of the main gate. Then (i) Bhuban Acharjee, S/o- Late Ajit Acharjee, Village & P.O.- Kanchannagar, Burdwan (Mobile No. 9002504339) (ii) Dipak Hazra, S/o- Shankar Hazra, Village & P.O.- Kanchannagar, Burdwan (Mobile No. 9083112067) (iii) Scumitra Banerjee, S/o- Late Madhusudan Banerjee, Village- Pandua, P.O.- Chandrahati, Hooghly (Mobile No. 8967592930) (iv) Dipankar Das, S/o- Deben Das, Village & P.O.- Kanchannagar, Burdwan (Mobile No. 9851952479), (v) Somenath Konar, S/o- Shri Samarjit Konar, Village & P.O.- Kanchannagar, Burdwan suddenly attack upon Shri Nemai Banerjee, N/G. Shri Sumit Mukherjee,(one of the workers) S/o- Late Asit Mukherjee, Village-Hairgram, P.O.- Hatgobindapur, P.S.- Memari, Burdwan tried to escape Shri Nemai Banerjee, N/G But Shri Bhuban Acharjee lead the team again and struck on the head of Shri Nemai Banerjee, N/G with a rod. He fell down and blood oozed out. Shri Sumit banerjee (one of the workers) then escape Shri Banerjee from attack of Bhuban Acharjee. Shri Nemai Banerjee, N/G himself with the help of Subodh Chakraborty, N/G, rush to the Sadar Hospital at about 10.30p.m. and also inform to the Town P.S. Police personnel came to the premises of the ADM & DL&LRO office and advised to inform the matter officially.


