Entered the premises of Surajit Chattopadhyay Vill Monitor, Fanda
P.S. Raghunathpur Dist- Purulia, having Consumer No. 202099985 Meter No. B3958481
and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S135(I) (b) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) light - 2m, 11) Fan - 1m.

Out of which I seized the following.
Tapping Portion of service cable approx. length - 1.5 ft
after disconnection from line.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left
the premises at 12.15 on 23/11/17. The accused person has committed an offence
U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
