Sub: Prayer for lodging FIR.

Sir,

With due respect I SI Proboadh Kr Mondal beg to state that I have been detailed for L/O duty along with force vide CC No 4082, GDE No 1442 dtd 30.10.17 at about 17:35 hrs at Kulsora village in c/w Immersion of Jagaddhatri Goddess of Brahmanpara. I reached there at about 18:00 hrs.

Before start of the Immersion procession I requested the Committee member to show the permission of Immersion Procession. They could not provide so. On the contrary, they said that they have only obtained the permission for celebrating the Puja at Mandap.

However for the sake of L/O problem, I remained there to ensure peace during immersion procession. The procession started with insufficient lights, 2 high-sound mike (CHONGA) with music system from Brahman Para, Kulsora at about 19:30 hrs.

While the procession was going on, at the time one Dumb boy namely Sanjay Rajak s/o Shaktipada Rajak of Kulsora, Bouri Para once undressed his pant while dancing with others on village road at about 21:30 hrs. Then one Bagu Bauri s/o Foni Bauri of Ekunja village along with other pulled him out of the possession and assaulted him with fist & blow. Later they have also pushed the dumb boy in the pond water. I alongwith my team tried to control & pacify. But the carriers of the Idol of Jagaddhatri Goddess were from Kulsora Bauri Para. They kept down the idol on the village more near Mahabir Mandir of Kulsora village & started demanding the arrest of the miscreants who assaulted the dumb boy.

On the other side, the Ekunja villager under the leadership of Gopinath Maji s/o Bhabani Majhi of Ekunja and Bagu Bauri s/o Foni Bauri of Ekunja started assembling to fight against the Kulsora Bauri Para & Brahman Para villagers.

The situation was turning grave. The Brahman Para Puja Committee members under the leadership of Prasanta @ Santu Banerjee s/o Susil started supporting the issue of Kulsora Bauri Para against the Ekunja villagers including the accused of Bauris. Both the villagers started abusing against one another & we, the police party took the position between them & continued pacifying them.

But finding no other option I have requested O/C Raghunathpur PS to send more force at about 22:15 hrs.

While the situation was getting worsened gradually and rapidly, the villagers with the advantages of the situation started pelting stone and thus police (NVF in Uniform - NVF/216 Nema Ch. Mahato and NVF/255 Shiba Prasad Mahato-who were detailed under C.C. No. 4083

dtd 30.10.17) sustained injuries. I have managed for shift them & tried to control the mob. Meanwhile the back-up force reached.

Seeing the strength of force, the mob started retreating. Later SDPO Raghunathpur, CI Raghunathpur & O/C Raghunathpur PS reached there with force from Police Line. SDPO Sir requested the organizer of Puja to arrange for immersion of the Goddess.

But since the carriers of the Idol of Goddess (who carries the Idol to pond on their shoulder) were not agreed to do their job, the members of Brahman Para took the Idol on their Shoulder & completed the Immersion at about 00:45 hrs. dtd 31.10.17.

Police team then foot patrolled in both the villages. Requested the villagers to provide complaint if any against anything or anyone & to go back home.

As per order of SDPO Sir, one picket party under SI Gopal Bhattacharyay with 20 numbers of force of Police Line kept there for picketing.

After foot patrol, SDPO Sir, CI, Raghunathpur & O/C Raghunathpur left the place.

I have seized 04 pieces of broken bricks as sample those which were thrown by the villager & which caused injuries to the above NVFs on duty there in between 02:05 hrs to 02:35 hrs on 31.10.17.

Since, the Puja Committee members violated Section 30 of Police Act, the villagers of Ekunja & Kulsora disobeyed the lawful order of the police as well as caused injury to the on duty NVFs, I pray for starting an FIR against (1) Bama Pada Banerjee S/O Sisir, (2) Jayanta Banerjee (3) Sibdas Banerjee (4) Sanjoy @ Joydeb Banerjee (5) Uttam Banerjee S/O Anadinath (6) Prasanta Banerjee S/O Sushil (7) Somnath @ Boro Banerjee, (8) Sanjib @ Lal Banerjee, (9) Biswajit Banerjee S/O Bikash (10) Nabin Banerjee, (11) Sanjoy Banerjee, (12) Swapan Banerjee, (13) Rajkumar Banerjee, (14) Somnath @ Kala Babu Banerjee, (15) Purna Chandra Banerjee, (16) Biren Banerjee, (17) Sanjib Banerjee all of Vill.- Kulsora, PS - Raghunathpur, Dist - Purulia, the Puja Committee Members (18) Jagadish Bauri s/o Chanu Bauri (19) Samiran Tantubai s/o Lalmohan (21) Biswas Tantubai s/o Sadhan , (21) Ukil Bauri s/o Ananda (22) Prasanta Bauri s/o Jagabandh of Do, (23) Raju Bauri s/o Madhu Bauri (24) Sukanta Mukherjee s/o Sadhan (25) Ananda Bauri s/o Lakhu Bauri, (26) Dinu Bauri s/o Gokul Bauri, (27) Ganesh Tantubay s/o Dayamoy (28) Sanjoy Rajak s/o Saktipada Rajak, all of Vill.- Kulsora Bauri Para PS - Raghunathpur, Dist - Purulia (29) Dilip Bauri s/o Foni Bauri (30) Bagu Bauri s/o Foni Bauri, (31) Muchiram Bauri s/o Madhab Bauri, (32) Bablu Das s/o Gusai Das, (33) Genta Bauri s/o Prahallad Bauri (34) Chambal Bauri s/o Prahallad Bauri, (35) Dim Bauri s/o Ratan Bauri, (36) Arjun Bauri s/o Anil Bauri, (37) Bablu Bauri s/o Anil Bauri (38) Gopinath Maji s/o Bhabani Maji all of Vill.- Ekunja, PS - Raghunathpur, Dist - Purulia and 500/600 unknown accused persons under proper section of law.


