AGHUNATHPUR P.S. That the complainant most respectfully beg to state as follows:-

- that the complainant is the resident of Barikbandh, Rakhatpur, P.S.- Raghunathpur, Dist.- Purulia West Bengal, within the jurisdiction of your ld. Court.
- that on 21/08/2017 at about 7.00 A.M. suddenly the complainant heard the hue and cry of his mother namely Gita Rani Bid, and on being heard, the complainant rushed to his mother and found that his mother was on earth and one RITA MANDAL W/O. Subrata Mandal was sitting on her chest and trying to strangulate his mother with a view to kill her

The complainant anyhow pushed said RITA MANDAL and save the life of his mother. Again said RITA MANDAL went to her mouse and came with her husband SUBRATA MANDAL who hold one age in his hand towards me and on seeing the same, the mother of the complainant though weeping, anyhow hold the legs of said SUBRATA MANDAL but said SUBRATA MANDAL throw her with threat that he will kill AKASH BID today and thereafter he assault the complainant with the said axe. And for which the complainant got the bleeding head injury. On seeing the incident, with a view to save the life of complainant, the co-villager namely SUBHAS CHANDRA PARAMANIK and SUKANTA TANTUBAI took the complainant to his house.

- 3. That the complainant was immediately taken to Raghunathpur S.D. Hospital by said SUBHAS CHANDRA PARAMANIK, where he has been medically treated by the doctors.
- 4. That the complainant went to Raghunathpur P.S. to lodged the complaint, but the concern P.S. has not received the written complaint but assaured him that they will do the needful.
- That after lapse of considerable period, when the concerned police station has not taken any steps as assured, the complainant made a application before the S.P., Purulia, dated 06/09/2017, with copy to O/C Raghunathpur 'P.S. about the incident vide registered letter dated 06/09/2016, but till to-day there is no any fruitful result.
- 6. That finding no other alternative, the complainant have to take shelter before the ld. Court for the redressal of her grievance.

It is therefore prayed before the Id. Court may kindly allow this petition treating the same U/S 156(3) of Cr.P.C., and to pass necessary order/orders, direction/directions, to the Officer In Charge, Raghunathpur Police Station to treat the same as F.I.R. against the above named accused persons and any other order/orders, direction/directions, as your Id. Court may deem fit and proper for the ends of Justice, And for this act of kindness the complainant shall ever prays.
