Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **BHOLANATH CHAKRABORTY, S/O- Late Naba Kishore Chakraborty of Village-Deoli, P.O. Deoli, P.S.-Santalidih, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 07.11.2017 at about 10.10AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with MR Avishek Das, SAE(E), Dubra Para CCC, Mr Sanjoy Prasad, TSH, Dubra Para CCC, Mr Bhaktipada Mahato, TSH, Dubra Para CCC and MR Patit Kora, Sr. TSH, Dubra Para CCC inspected the premises of **BHOLANATH CHAKRABORTY, S/O- Late Naba Kishore Chakraborty of Village- Deoli, P.S.-Santalidih, Dist Purulia**. During inspection it was found that the said **BHOLANATH CHAKRABORTY** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 02 nos LED Tube light, 01 no Ceiling Fan, 01 no stand Fan, 02 nos bulb, 01 no motor, 02 nos LED light, approx load 0.765 KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 10.45PM.

As such **BHOLANATH CHAKRABORTY S/O- Late Late Naba Kishore Chakraborty of Village-Deoli, P.S.- Santalidih,, P.O Deoli, Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
