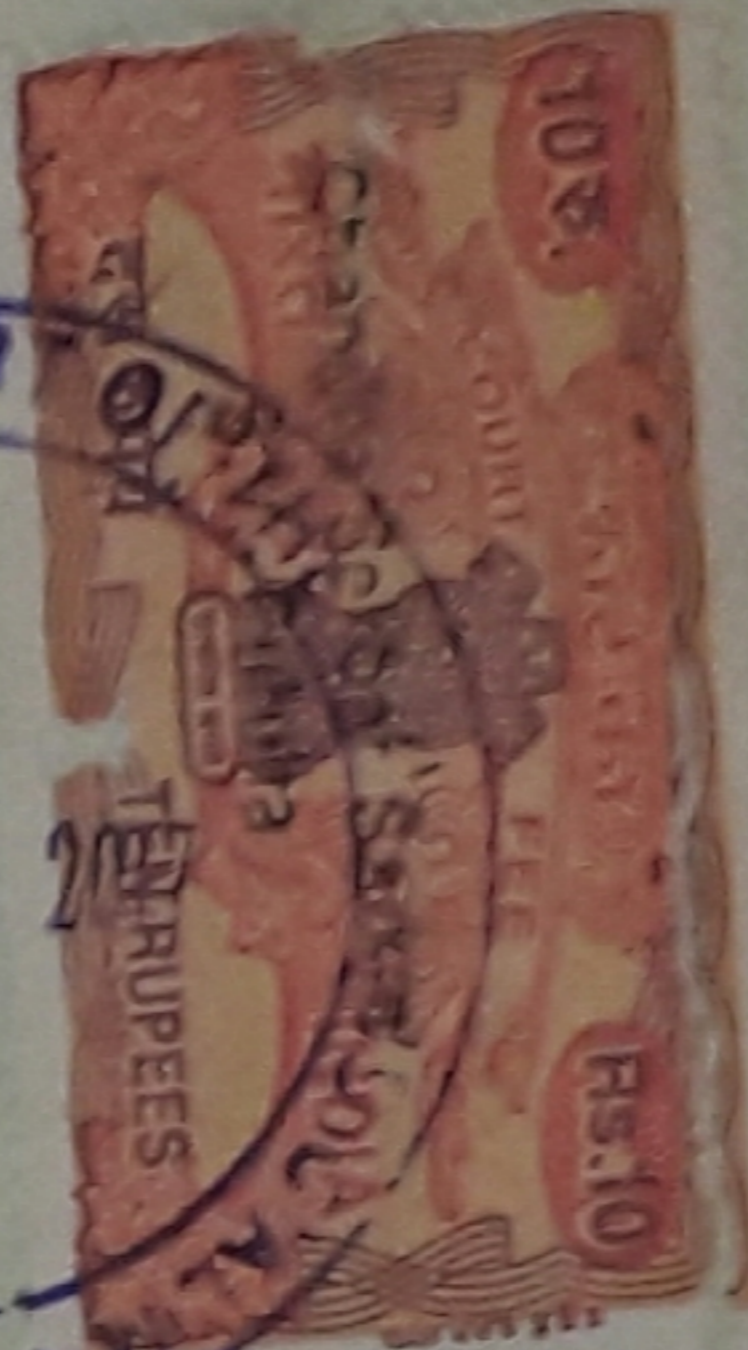

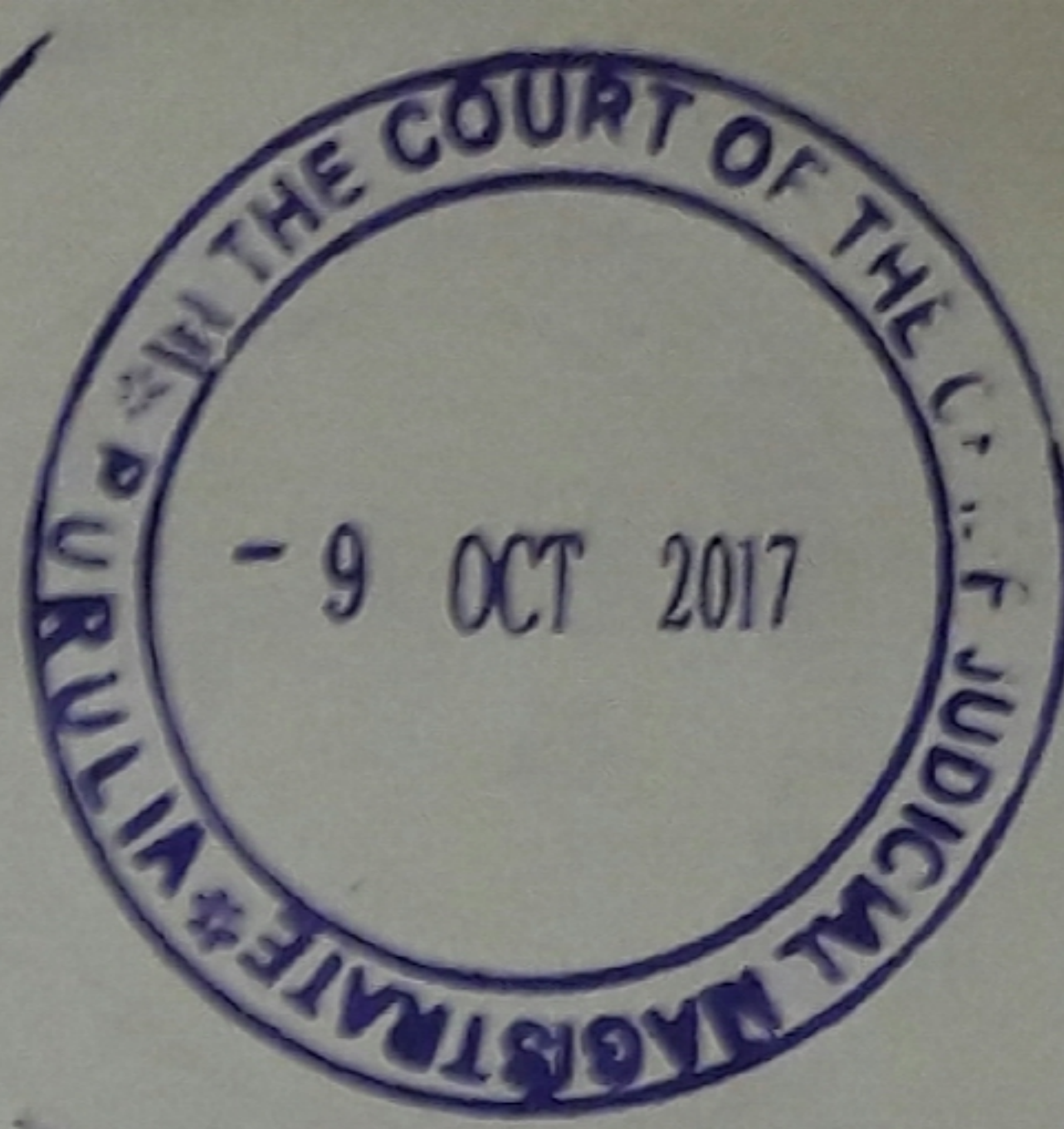

The above named complainant begs to state as follows :-

Most respectfully sheweth :-

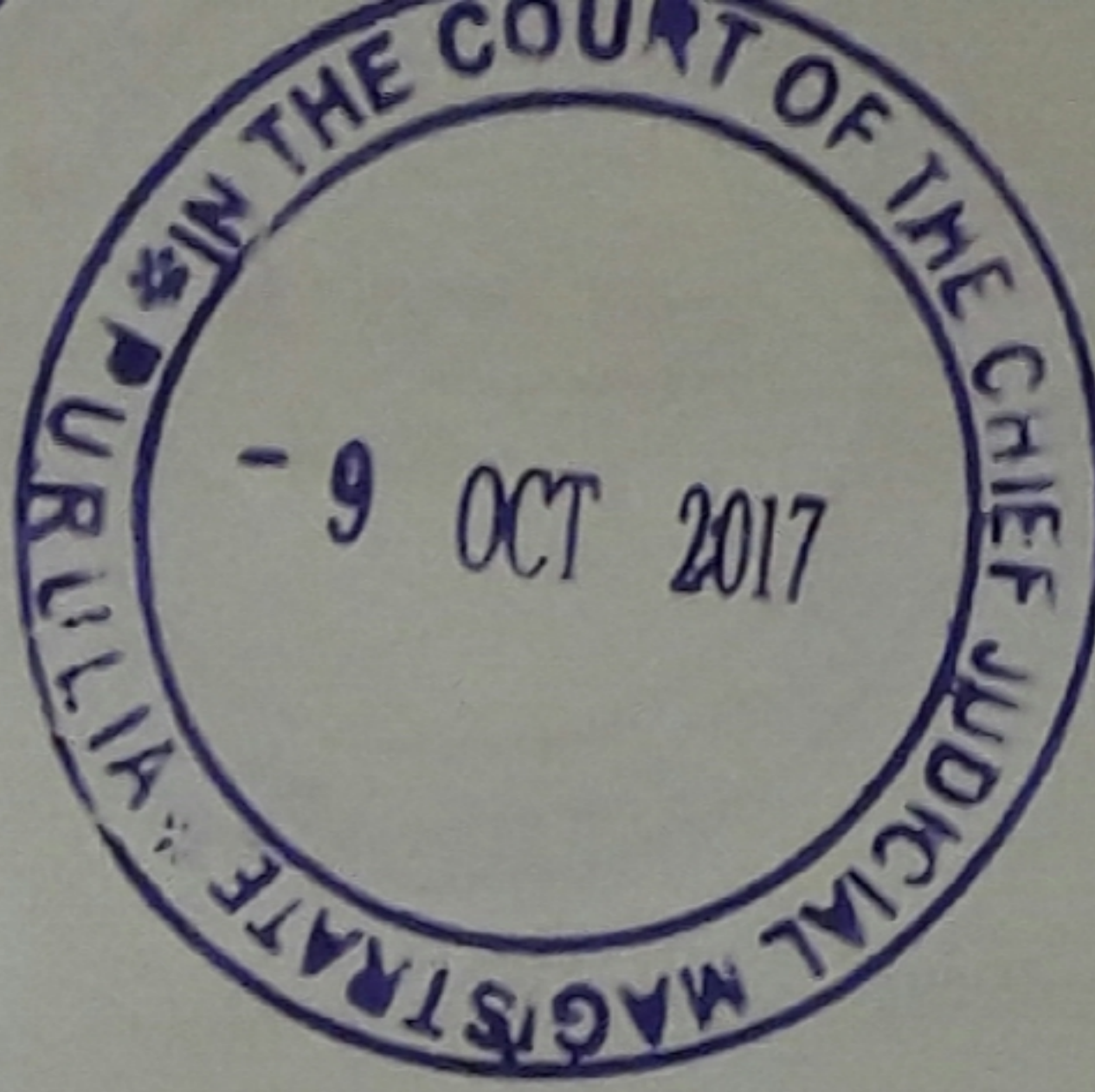
1----That the complainant is the legally married wife of accused Bibhishan Roy .The parties are Ghatwal by caste and Hindu by religion Their marriage was solemnised on 20-04-2012 , according to their customary rites and formalities prevalent in their community . Their marriage was consummated and the marriage tie between them still in subsistence.

2----That at the time of marriage , her father had to give considerable dowry including a hard cash of Rs. 2,50,000/-to accused Bibhishan Roy and his mother but they were not satisfied with the same .

3----That after marriage your petitioner had been to her matrimonial home and started living there as husband and wife for about one month peacefully . Thereafter her husband Bibhishan Roy, mother in law Sarala Roy , brother in law Gouranga Roy, sister in law Alta Roy and uncle in law Ashoke Roy started a fresh demand of Rs.1, 00,000/-and a Motor Cycle from her father. Her poor father again gave Rs. 2000 but he could not meet the whole fresh demand and for that all the accused persons combinely started mental and physical torture, cruelties, harassment upon your petitioner and spoke out that her husband would contract second marriage with another girl which would ensure further lucrative dowry , they threatened . Off and on , she was drove out by the accused persons frequently from her matrimonial home after severe assault which is beyond description.

4----That since her poor father could not fulfil the fresh demand of the accused persons at this, the petitioner was subjected to mental and physical torture by the accused persons in various false

pretexs . The petitioner being the devoted Hindu wife tolerate all the humiliation , harassment , mental and physical torture, assault and cruelties exercised upon her by the accused persons , she was denied bare necessities of life , she was refused to keep in her matrimonial home the accused persons . Her mother in law and sister in law did not allow her to enter the bed room of her husband . Of and on she was drove out by the accused persons after assault .

5----That it may be mentioned here that her husband has develop illicit relation with accused Alta Roy and passed nights with her in his bed room . Similarly accused Ashoke Roy also developed illicit relation with accused Sarala Roy and they lived together as husband and wife . When the petitioner requested her husband to leave the company of Alta Roy , then her husband and accused Alta Roy, Sarala Roy and Ashoke Roy jointly assaulted the petitioner mercilessly and asked her to go to her father`s house and commit suicide . Again and again her father and others reached her to her matrimonial home but she was behaved with cruelty for non fulfilment of their demand . It was daily routine of the accused persons to assault the petitioner . The petitioner was helpless in the matter bears those torture and assault patiently on the hope that her husband others in laws would mend their attitude and would be normal towards her but hopes were shattered . Day by day torture and assault were gradually exercised on her which is beyond description .

6----That over the issue of fresh demand and over the issue of Alta Roy , the accused persons mercilessly assaulted the petitioner on 30-07-2016, and drove her out from her matrimonial home and since the petitioner is living in her father`s house at village kultarr under Purulia (M) Police station . Again her father and one Shova

Mahato reached her to her matrimonial house but she was not allowed to enter the house by the accused persons .

7----That the petitioner had informed all about her ordeal to the local police station .The police assured her to take appropriate legal action against the wrong doers but it is a matter of regret that till yet no specific case has been started against the accused persons best known to them .Finding no other alternative your petitioner knocked the door of the superintendant of Police Purulia on 21-04-2017, but nothing has been done by his good office.

8----That your petitioner has no source of income of her own . She is in acute distress and poverty and helpless and destitute lady . The consequences of torture and assault have placed her in a corner and she is under constant mental shock and agony . She has no money to pull the case , to conduct the case in her private capacity . More over there are some legal aspect and technicalities like search and seizure which requires considerable money and machinery which can not be responded in a complaint oriented case . So a police case is highly desirable .

It is prayed that your Honour may be graciously pleased to direct the Officer In – Charge Santaldih Police Station to investigate the case in accordance with law , treating the same as F.I.R., as completed U/S 156(3) Cr. P.C.
