Entered the premises of Bhalu Kumbhakar, Vill Agutard P.S. Santalchi Dist- Purulia, having Consumer No. 242052874 Meter No. 82693777

and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- ① Tr - 01, ② Fan - 2, ③ CFL - 6 ④ Free - 01

Out of which I seized the following.

Passing portion of service connection cable (PCC) 3 ft (approx)

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 1.50pm on 08/11/17. The accused person has committed an offence U/S135(I)(b) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
