I do hereby lodge complaint empowered by enabling The Electricity Act-2003,  
Subsequently Electricity (Amendment) Act-2007 to the effect that Sri Ashis Nandi S/o - Sri Gabardhan  
Nandi, Vill - Madhubampur PO - Muradi was enjoying electricity at  
his poultry firm by means of direct hooking from the LTOH line  
of W.B.S.E.D.C.L. His illegal activity

has committed theft of electricity U/S 135 of The Electricity (amendment Act-2007)

Entered the premises of Sri Ashis Nandi S/o - Gabardhan Nandi  
Vill - Madhubampur PS - Santuri Dist - Purulia  
(Poultry firm)

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she  
was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of  
W.B.S.E.D.C.L. i.e. U/S-135 (I) (a) was detected.

From the above arrangement he/she was using the following electrical equipments

- 2) Bulb - 01 no of 100W

The accused person has committed an offence U/S 135 (I) (a) of The Electricity Act 2003 & subsequently  
Electricity (Amendment) Act-2007.

taken as per rule.
