During inspection theft of electricity was detected i.e. He/she was using electricity dishonestly by taping the incoming cable of the energy meter installed in the said premises and therefore bypassing the energy meter of W.B.S.E.D.C.L. i.e. U/S 135 (I) (b) was detected.
