



## The above name complainant begs to state as follows:

- That the complainant is the legally married wife of accused no-1 and their marriage was solemnized on 28th Ashar 1421 B.S. and said marriage was solemnized as per Hindu Rites and customs following social rituals, and also observing all the Hindu customary rites.
- 2) That at the time of marriage the widow mother of the complainant after taking loan practically, by begging somehow managed to pay a cash of Rs. 50,000/- along with gold and silver ornaments and other valuable articles as per demand of the husband of the complainant as per condition of the said marriage.


That after marriage the complainant went to her matrimonial house and started to reside as husband and wife with the accused no-1 with other inmates of the family in same house and mess. But since after the marriage her husband and other in-laws after few days behaved unnaturally for which the complainant very much socked. However the complainant did not take it exceptional but the complainant thinks that after passage of time everything would be normal, but the accused persons after few days of marriage demand Rs. 25,000/- as further dowry on the plea that the cash and kinds so giving out at the time of marriage was insufficient and unless the said demand be fulfilled the complainant would have to face consequences and they started all sorts of inhuman, physical and that torture upon the complainant and also will not provided proper food and clothing they even assaulted the complainant after closing the door and windows of the room they also gave out that unless the said demand be fulfilled by their mother the complainant will not be allowed to stay at her matrimonial house as not be allows to continued her matrimonial / conjugal life the

husband as well as other inmates of the family never loved the complainant and never behaved the complainant well.

- 4) That in-spite of the said behaved the complainant persistent torture upon the complainant and ultimately on 16th Sraban 1421 B.S. the complainant was assaulted mercilessly by the accused parsons and driven her out from their house after snatching all her belonging. Stridhan, including her ornaments.
- That since thereafter the complainant is residing at her paternal house and that the accused persons never taken any information of the complainant nor make any arrangement to take her back in their house, but bother and other relation of the complainant on so many occasions requested the accused persons to take back the complainant and keep the complainant with proper care and prestige and not to torture upon the complainant but all the time they denied.
- 6) That the complainant thereafter lodged one complaint to the local P.S. and when no legal action was taken by the said Police then another complaint was lodged to the





Superintendent of Police Purulia but same fate. Hence the complainant is under compelling circumstance filed this complaint before this Ld. Court under the law.

In the circumstances it is therefore, prayed that your honour may be pleased to send the petition of complaint to the Officer-in-charge.
