I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Apu Mahato S/O- Sri Gurupada Mahato of villege Khirabera (Banghari) ~~no~~ P.S- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 16.12.2017 at about 11.20 AM I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Sukhamoy Maji, SAE 2. Sri Subhashis Mahato OF 3. entered the premises of Sri Apu Mahato S/O- Gurupada Mahato of villege - Khirabera (Banghari) ~~no~~ P.S- Bagmundi, Dist- Purulia and found Sri Apu Mahato was enjoying electricity unauthorizably drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Apu Mahato S/O- Sri Gurupada Mahato committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukhamoy Maji SAE 2. Sri Subhashis Mahato The inspection team left the premises at 11.30 AM.
