Sub: Lodging F.I.R against Shyamapada Ojha, S/o. Lt. Rakhahari Ojha for unauthorized use of Electricity by way of hooking u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Sir,

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, A.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Shyamapada Ojha, S/o. Lt. Rakhahari Ojha resides at Vill - Tilai, Po. Ghatbera, PS : Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information today on 05.12.2017 from 4.35 PM to 4.55 PM I, along with Jiaur Rahaman Mondal A.E (S &LP) Unit Purulia Region, Sri Sankar Ch. Mahato, Linesman (S &LP) Unit Purulia Region, Sri Dayamay Mahato, TSH (S &LP) Unit Purulia Region, Sri Anup Mandal, S.A.E , Sri Amit Kumar Hela, O.E Balarampur CCC inspected the premises of Shyamapada Ojha and held raid.

During raid and inspection it was detected that accused Shyamapada Ojha is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 1 No. 100 Watt Lamp, 2 Nos. Ceiling Fan, 1 No. Electric Pump (1/2HP), 6 Nos CFL and 1 No. TV having connected load 0.763 KW. There exists one Service Connection of WBSEDCL bearing Consumer ID : 242089011 stands recorded in the name of the deceased father of the accused which was in disconnected condition due to non payment of energy bill.

I prepared Inspection report in presence of the representative of the Accused and assessed the Load as 0.763 Kw. Details have been mentioned in the Inspection Report and duly signed by the representative of the Accused.

I directed Sri Sankar Ch. Mahato to disconnect the hooking line from our LTOH line. Accordingly he disconnected the aforesaid hooking line from LTOH Line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the representative of the accused. A copy of the seizure list was handed over to the representative of the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
