Mahato, Linesman (S &LP) Unit Purulia Region, Sri Dayamay Mahato, TSH (S &LP) Unit Purulia Region, Sri Anup Mandal, S.A.E , Sri Amit Kumar Hela, O.E Balarampur CCC inspected the premises of Shyamapada Ojha and held raid.

During raid and inspection it was detected that accused Shyamapada Ojha is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 1 No. 100 Watt Lamp, 2 Nos. Ceiling Fan, 1 No. Electric Pump (1/2HP), 6 Nos CFL and 1 No. TV having connected load 0.763 KW.
