- That after a span of few months of the marital tie, the accorded no. 1,2, and 3 started torture upon the petitioner both physically and mentally.
- 4. That during the wed-lock, the petitioner became pregnant and due to the savere physical torture upon the petitioner by the accused no.1 the husband and accused no.2 &3., the father in law and mother in law of the matrimonial family members, the pregnancy was miscarriage and the petitioner became physically weak and mentally shocked.
- 5. That the accused no.1 Dilip Kumar Mandi, the husband, the accused no.2, Umasan Mandi the father in law and the accused no. 3, Smt. Saraswati Mandi the mother in law voluntarily causes physically assault to the petitioner causing miscarriage of the pregnancy of the petitioner.
- 6. Be it mentioned here that the accused no. 1 Dilip Kumar Mandi, accused no.2 Umasan Mandi and accused no. 3 Smt. Saraswati Mandi used to call the petitioner as 'DAINI' and cursed the petitioner that the she will not be able to give birth a child. The above named accused persons used to call Rita Murmu the mother of the petitioner as 'DAINI'.
- 7. That recently the accused no.1 Dilip Kumar Mandi is living with a lady namely Tagar Hansda, the accused no.4 of vill- Golkata, P.O- Kashmar, P.S. Kamalpur, Dist.- East Singhbhum and have made cohabitation deceitfully with that lady with the instigation and convenience of Balaram Hansda, the accused no.5 and Musuri Hansda, the accused no.6.
- That the accused no.1 Dilip Kumar Mandi have illicit relation with the accused no.4 Tagar Hansda and have made cohabitation with that lady.
- That the petitioner being the wife of accused no.1 Dilip Kumar Mandi, who is alive still then the accused no.1 Dilip Kumar Mandi being the husband of the petitioner trying to marry the accused no.4 Tagar Hansda and have concealed the former marriage and the accused no.1

Dilip Kmar Mandi is living a adultarious life.
