The above named complainant/petitioner;  
Most respectfully begs to state as follows:-

1. That your complainant/petitioner is the legally married wife accused no.1 namely Kartick Hembram and the marriage has been solemnised on 26th day of Jaistha 1424 B.S. corresponding to 10.6.2017<sup>AD</sup> per social right and customs prevalent in their community observing all the formalities and the said marriage is still subsisting.
2. That at the time of marriage father of the petitioner compelled to pay all the dowry articles alongwith other <sup>amount</sup> ~~amount~~ as per demand of the accused person but the accused person were not fully satisfied with the articles alongwith other things.
3. That as the accused persons are not satisfied with the dowry articles so after few days from the date of marriage they started physical as well as mental torture upon the petitioner. Here be it mentioned that petitioner is a Schooler student where as accused Kartick was a general student and at the time of marriage accused persons able to convinced the father of petitioner regarding the goodness and well character of the accused/husband Kartick Hembram but it has totally false and as and when petitioner raised some question regarding the illbehave of the accused person upon the petitioner then the accused person use to start physical assault upon the petitioner even conspired with other two accused persons

they snatched the mobile phone of the petitioner due to doubt and for the reason that petitioner will unable to contract with her family members as well as other friends and relatives.

4. That due to mental torture and physical assault, your petitioner/complainant informed the matter to her father and other villagers people and they came to her matrimonial house on 29.7.2017 for the purpose of compromise the matter relating to the unusual relation with accused Kartick Membram and his elder brother's wife and also relating to physical as well as mental torture but <sup>suddenly</sup> snatched in the evening the accused person restrained them in a room and by the help of some antisocial person <sup>accused</sup> and persons demanded Rs.10,000/- otherwise petitioner alongwith <sup>her</sup> father will face the dire consequence.

5. That on the next day at about morning when complainant's father denied to give the money they snatched Rs.9,500/- from father of the complainant and after assaulting mercilessly to your petitioner and her father they driven out from the house to your petitioner and her father alongwith the person who came with her father.

6. That no other alternative your petitioner informed the matter to local P.S. Bandwan and Boro but they did nothing on the saying that it is your social matter.

7. That lastly on 24.10.17 your petitioner informed to the O.C. Bandwan P.S. as well as S.P.Purulia but all in vain.
8. That being the deserted lady and the petitioner has no sufficient fund to conduct the case as such petitioner have no other alternative but to take the shelter of sec.156(3) to Booked the criminal as per provision of law .

It is therefore prayed that your Honour may graciously be pleased to sent this complaint petition before the O.C.Bandwan after treating this as F.I.R. for investigation and necessary action as per provision of law.
