








- That the complainant, accused person and the witness Nos. 3 and 5 are the
 permanent residents of Village Jamtoria within P.S Boro, under Jamtoria I. C and
 within the District of Purulia and the Witness Nos. 2 and 6 are the residents of
 Village and Post Jharbagda, P. S. Manbazar, District Purulia.
- 2. That Danish Chandra Singha Mahapatra, the above named accused was the owner and title holder of the portion of land bearing R.S Plot No. 933 appertaining to R.S Khatian No.288 of Mouza Jamtoria measuring an area of 11 decimals.
- That Kalipada Singha Mahapatra, died leaving behind him his three sons namely Kshitish Chandra Singha Mahapatra, Danish Chandra Singha Mahapatra, the accused and Anish Chandra Singha Mahapatra.
- 4. That the land bearing R. S. Plot No. 933 appertaining to R. S. 




- 7. That for several times, the father of the complainant as also the Complainant asked the Accused Person to remove the difficulties created by him over the plot No. 933 and ultimately a Pleader Notice was served upon the accused on behalf of the father of the Complainant.
