(10) Byasadeb Panda accompanying with five hundred others B.J.P. supporters to the effect that on 26.11.17 on behalf of Sunil Kumar Mandal, B.J.P. Hura Mandal President (Z.P.-B.D.) submitted petition praying for permission to organize a procession from Lalpur Moh to Kendbonia Moh on 05.12.17 from 12.00 hrs. to 18.00 hrs. along the NH 60A. The prayer was considered and they were permitted to organize the same procession.

On 05.12.17 at about 13.30 hrs. the said procession was started from Lalpur Moh on NH 60A under the leadership of above noted persons sl. no.(1) to sl. no-(10). About 500 people gathered in the said procession. The procession was under Police control. SI-Bablu Ghosh along with force were in front of the said procession to avoid any untoward incident.

At about 14.30 hrs. the said procession reached in front of Hura PS. main gate. Suddenly the above noted leaders attempted to mobilize the entire procession into the PS. compound. Seeing this SI-Bablu Ghosh tried his best to restrain the procession from entering into PS. compound. But the above noted leaders, Abdul Alim Ansary in particular instigated the mob not to pay any attention towards the request of SI-Bablu Ghosh. As the situation was about to be gone beyond control, I myself along with my accompanying force rushed to the PS. main gate and requested to the leaders of the said procession not to enter into the PS. compound with a such huge mob. In this situation I requested to headquarters to send re-enforcement. I also gave them proposal if they had any demand their representatives (five or ten persons) might come to my office chamber and a dialogue might be done to fulfill the demand. But the above noted leaders were not in a mood to place their demand in a systematic way. More over they instigated the mob and the mob became more furious. They pushed me on the ground and ran towards the office. The others force and officers obstructed them from entering into my chamber. Then they started pelting stones and brickbats towards us. They also attacked and assaulted us with bamboo made flag stick with a view to cause grievous hurt to the Police personnel. As a result of that I, myself along with SI-Bablu Ghosh, C/669 Subrata Banikar, C/241 Sunil Chakraborty, C/354 Tapas Panda, DYC-86 Falatuddin Ansary, NNF/592 Suchand Mirmu, NNF/544 Nitin Modak, NNF/867 Shankar Ch. Dey, SIC Tamratrichel sustained injuries. By this time Abdul Alim Ansary and Arik Mandal along with some others managed to enter into the office chamber of the duty officer by overpowering us and damaged the said office. They also damaged the following Govt. properties (1) 02 (two) molded chair, (2) One wooden chair, (3) One wooden table, (4) two tube light, (5) two traffic materials.

By this time the re-enforcement officer and force came to the PS. and seeing this additional Police force the unruly mob fled away from the PS. compound. We tried to apprehend them but they managed to escape. After that we went to Hura Rural Hospital and got medical treatment.

As at the instigation of the above noted leaders the unruly mob restrained the Police party and assaulted them causing injuries of their persons while they were in course of duty and as they damaged the public properties, they are liable for prosecution u/s-147/148/447/186/353/332 I.P.C. and U/s-3/4 P.D.P.P. Act-1984.

As such I am starting this case sno-moh u/s-147/148/447/186/353/332 /333 I.P.C. and 3/4 P.D.P.P. Act-1984 against - (1) Sunil Kr. Mandal, Hura Mandal President (Z.P.-B.D.), (2) Abdul Alim Ansary s/o Abenai Ansary, Vill.-Kajuli, PS- Hura, Dist- Pla, (3) Arik Mandal s/o Pashupati Mandal Vill- Lalpur, PS- Hura, Dist- Pla, (4) Manik Mahato Vill- Shambukgaria, PS- Hura, Dist- Pla, (5) Anup Kr Mahato s/o Rangit Mahato, Vill- Barigrami, PS- Hura, Dist- Pla, (6) Biswajit Mondal s/o Birchand Mondal, address - do - , (7) Mahananda Karmakar s/o Lohani Karmakar Vill- Majumdarhati, PS- Hura, Dist- Pla, (8) Debabirata Mahato s/o Prafulla Mahato address - do - , (9) Prasad Dutta s/o Narendal Dutta, Vill- Kendbonia, PS- Hura, Dist- Pla, (10) Byasadeb Panda accompanying with five hundred Others B.J.P. supporters and SI-Biswajit Sarkar will investigate this case.
