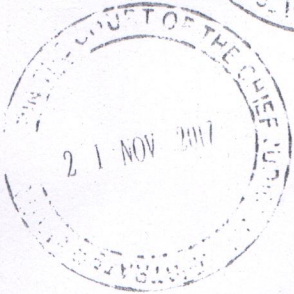

The above named complainant;

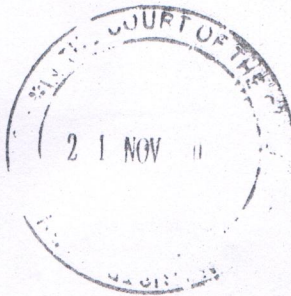
Most respectfully begs to state :-

- 1... That the complainant and accused persons are the permanent resident of village Rokhera, P.S. Hura, District Purulia.
- 2... That West Bengal Govt has given Patta to the landless persons of the local area of Hura P.S. like this W.B. Govt. on 9.4.2010 has executed a land measuring an area of 55 decimals in R.S. Plot No. 3322 of Mouza Rokhera in Patta Case No. 4/2010 in favour of Salim Sk. elder son of the complainant and delivered the Patta land to the Patta holders.
- 3... That Sk. Salim Patta holder due to his difficulties entrusted his patta land to the complainant by executing a Power of Attorney with respect to cultivating and looking after the patta land Regd. Power of Attorney No. 140/15 dated 8.5.15 and as per said Power of Attorney the complainant has been cultivating the said Patta land and like previous years, the complainant has transplanted paddy seedlings and the paddy cropse were satisfactorily.
- 4... That on 5.11.17 at about 9 A.M. all the accused persons with other 6 persons being armed with Lathi, axe, Kaste, forcibly and illegally entered into the Patta land and started to harres the paddy cropse at that time the complainant with his wife were doing work

at the field near the patta land, seeing the illegal entrance and cutting the paddy crop by the accd. came to the spot forbidden the accd. persons but the accused persons become furious and chased with lathi etc. The complainant and wife being few in number saved their lives by leaving from thers. The all accused persons have forcibly cut the paddy crop and taken away those Tractor.

5.. That the accused persons having no right, title, interest or possession over the said land have committed offences ~~punishable~~ punishable under I.P.C. and by the illegal acts. The complainant sustained a loss of Rs. 13,000/-

6... That the complainant informed the incident dated on 5.11.2017 to the O.C. Hura P.S. when Police assured to enquire the matter but did not do when the complainant lodged complain to S.P.Purulia on 10.11.2017 but the S.P.Purulia is also not taking any step against the accused and hence the complainant compelled to come to court.

It is prayed that your Honour would be pleased to send this petition of complain to the O/C Hura P.S. U/S 156(3) Cr.P.C. treating this as F.I.R. for investigation.

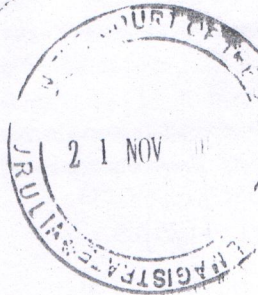
