




The above name complainant begs to state as follows:

That the complainant previous year this year also has transplanted paddy over those lands which are became ripe and for harvesting. It may be mentioned herein that the complainant is residing at village- Burudih, under P.S. 'Bagmundi, where as the accused persons are residing within the mouza where the land is situated and previous occasions tried to dispossess the complainant and threatened them with due consequences. However, the complainant never takes it explanation but to go on possess those lands.

- That like previous years this year also the complainant are transplanted paddy in the last rainy season the paddy is ripe for harvest.
- That on the date of i.e. 08/11/2017 the complainant was informed that the accused persons trespassed in the land and started to cut paddy growing by the complainant.


