Sir,

In producing herewith one arrested accd. Persons namely one Madhusudan Majhi (36) S/O- Khudiram Majhi of Karihansha, PS-Bagmundi, Dist-Purulia brought under arrest with seized articles 1)15 Ltrs I.D liquor kept in one white Jaricane valued Rs-600 2) 40 sealed bottles of country spirit (DIL KHUSH 80* up) containing 600 ml each valued Rs-1400/-and Rs-300/- as sale money from his possession. I do hereby lodged this written complaint to the effect that on-22/12/2017 at about 19:45 hours when I and along with my force namely C/1221-Laxmikanta Bauri, C/1147-Bappaditya Nandi vide CC No-3454/17 Dtd-22.12.17 Vide GDE No-874 Dtd-22.12.17 was performing mobile duty near at Borogram Bagan more on Purulia Ranchi road under Vill- Barogram Bagan, PS- Jhalda, Dist- Purulia, I received a source information that ID Liquior and other country liquor like Dilkhus etc has been selling by the owners namely Ranjan Ghosh the partner and the above noted arrested accused person at A Hotel styled as "Akash Hotel" and they have been running business of liquiors including ID liquiors since long being supplied by the others from Jharkhand state. Both the accd. persons keeping and selling of liquiors habitually since long. I informed the matter to I/C Jhalda PS and as per his direction, held raid and searched the mentioned Hotel. During search, seeing police party two persons started to flew away and after a small chase we could able to detain the above mentioned arrested accd person who on asking disclosed his identity as noted above and he also disclosed the identity of his partner who fled away namely Ranjan Ghosh S/O-Ritupurna Ghosh of Vill- Barochangru, PS-Silli, Dist-Ranchi, Jharkhand. During interrogation he could not produce any valid licence in favour of ID Liquiors and other country liquiors. Hence they violated the provision of 46 (A)(c) of B.E. Act.

Accordingly, I seized the above mentioned articles 1)15 Ltrs I.D liquor kept in one white Jaricane valued Rs-600 2) 40 sealed bottles of country spirit (DIL KHUSH 80* up) containing 600 ml each valued Rs-1400/-and Rs-300/- as sale money from his possession in proper seizure list duly signed by the police witnesses as there was no other witnesses available there with proper labelling and seal and arrested the above noted accd person informing him ground of arrest. On further Interrogation he stated that they used to kept and sell the said country spirit and ID liquor to the customer those who come for taking meal since long for their illegal gain.

I along with force on return to PS along with accd person and all seized articles. Put the accd. Person in the Lock Up after maintaining all formalities and hand over the seized articles to the Malkhana officer and submitted this written complaint before you to start a case against 1) Madhusudan Majhi (36) S/O-Khudiram Majhi of Karihansha, PS-Bagmundi, Dist-Purulia 2) Ranjan Ghosh S/O- Ritupurna Ghosh of Vill-Barochangru, PS-Silli, Dist-Ranchi, Jharkhand under proper section of law.
