In producing herewith one arrested accd. Persons namely one Bhagbat Mandal @ Guddu (25) S/O Lt. Balaram Mandal of Vill- Ghutia, PS- Jhalda, Dist-Purulia brought under arrest with seized articles 1)15 Ltrs I.D liquor kept in one white Jaricane 2) 24 sealed bottles of country spirit (DIL KHUSH ) containing 600 ml each 3) 20 sealed bottles of country spirit (DIL KHUSH ) containing 375 ml each 4)one small plastic container, containing approx 100(hundred) gm Nishadal from his possession. I do hereby lodged this written complaint to the effect that on-27/12/2017 at about 13:15 hours when I and along with my force namely L/Nk- Dawasing Bhuti, R/M-1581 Dawa Shaja vide Jhalda P.S. CC No-3487/17 Dtd-27.12.17 Vide GDE No-1023 Dtd-27.12.17 was performing mobile duty near at Mahatomara more on Gola road under P.S-Ihalda, Dist-Purulia, I received a source information that ID Liquor and other country liquor like Dilkhus etc has been selling by the owners namely Bhagbat Mandal at his residence house and he has been running business of liquors including ID liquors since long being supplied by the others from Iharkhand state. Accd. persons keeping and selling of liquors habitually since long. I informed the matter to I/C Jhalda PS and as per his direction, held raid and searched the mentioned house. During search, seeing police party he started to flew away and after a small chase we could able to detain the above mentioned arrested accd person who on asking disclosed his identity as noted above. During interrogation he could not produce any valid documents in favour of ID Liquors and other country spirit. On further Interrogation he stated that he used to kept and sell the said ID liquor after mixing Nishadal and he also confessed that this I.D liquor could be dangerous for human life even caused death to human life .

Accordingly, I seized the above mentioned articles 1)15 Ltrs I.D liquor kept in one white laricane 2) 24 sealed bottles of country spirit (DIL KHUSH) containing 600 ml each 3) 20 sealed bottles of country spirit (DIL KHUSH ) containing 375 ml each 4)one small plastic container, containing approx 100(hundred) gm Nishadal from his possession in proper seizure list duly signed by the public witnesses with proper labelling and seal and arrested the above noted accd person informing him ground of arrest, those who come for taking meal since long for their illegal gain.

I along with force on return to PS with accd person and all seized articles. Put the accd. Person in the Lock Up after maintaining all formalities and hand over the seized articles to the Malkhana officer and submitted this written complaint before you to start a case against Bhagbat Mandal @ Guddu (25) S/O Lt. Balaram Mandal of Vill- Ghutia, PS- Jhalda, Dist-Purulia under proper section of law.
